ORDER OF THE DEPARTMENT OF EMPLOYE TRUST FUNDS REPEALING, RENUMBERING AND AMENDING RULES

DEC 1 1982

To repeal ss. Ret 8.01, 8.02, 8.03, 8.04, 8.05 (1) and 8.06; to renumber and amend s. Ret 8.05 (2) relating to Wisconsin Retirement System variable annuities.

Analysis Prepared by the Department of Employe Trust Funds

On April 30, 1980, the variable division was closed to future participation making ss. Ret 8.01 and 8.02 no longer necessary. The provisions of ss. Ret 8.03, 8.04 and 8.05 (1) are now statutory making the rules redundant.

The amendment to s. Ret 8.05 (2) conforms the effective date of a variable increase or decrease to March 1 for all members of the Wisconsin Retirement System. Renumbering this section places it within the newly proposed chapter ETF 20 which is being created by the promulgation of another rule prior to this rule. Eventually, all rules administered by the Department of Employe Trust Funds will be in the ETF series to facilitate locating rules and to correspond more closely to the organization of ch. 40, Stats., as created by ch. 96, Laws of 1981.

Ret 8.06 applies to a very small closed group of annuitants of the former Wisconsin Retirement Fund with a death benefit payable under very rare and specific circumstances and it appears unlikely that such circumstances will occur. If it is ever determined that a death benefit is payable under these circumstances the death benefit would be based on the rules in effect at the time the annuity started.

These rules interpret ss. 40.04 and 40.28, Stats., as created by ch. 96, Laws of 1981.

Pursuant to the authority vested in the Department of Employe Trust Funds by s. 40.03 (2) (i), Stats., as created by ch. 96, Laws of 1981, the Department of Employe Trust Funds hereby repeals, renumbers and amends rules interpreting s. 40.04 and 40.28, Stats., as created by ch. 96, Laws of 1981, as follows:

SECTION 1. Ret 8.01, 8.02, 8.03, 8.04 and 8.05 (1) are repealed.

SECTION 2. Ret 8.05 (2) is renumbered ETF 20.25 and as renumbered is amended to read:

ETF 20.25 VARIABLE ANNUITY CHANGES. Annuity changes made in accordance with sub: -(1) the December 31 valuation as specified in s. 40.28 (2), Stats., shall be effective in-the-third-month on March 1 of the ensuing-ealendar following year, and shall apply to all annuities with an effective date on or prior to such-ensuing-year-whether-or-not-approved-in-a-prior-year---Annuities-with-an effective-date-in-an-ensuing-calendar-year-shall-not-be-changed-until-the-next redetermination-made-in-accordance-with-sub;-(1)-requires-a-change the December 31 valuation, regardless of whether the annuity becomes a fixed annuity in the following year.

SECTION 3. Ret 8.06 is repealed.

The rules contained in this order shall take effect as provided in s. 227.026 (1) (intro.), Stats.
