

ORDER OF THE

BOARD OF VOCATIONAL, TECHNICAL AND ADULT EDUCATION RENUMBERING RULES

To renumber Chapter A-V 1 to 8, 10 and 11, relating to various subjects affecting vocational, technical and adult education.

ANALYSIS PREPARED BY THE BOARD OF VOCATIONAL, TECHNICAL AND ADULT EDUCATION

The Board is proposing to change its acronym identifying its administrative rules from A-V to VTAE. By proposing this change, the Board is of the opinion that the ability of the general citizenry of the State to locate the rules of the Board will be enhanced. In adopting the acronym VTAE, the rules of the Board will maintain their present position in the administrative code.

Pursuant to authority vested in the Board of Vocational, Technical and Adult Education by sections 38.04(1) and 227.014(2)(a), Stats., the Board of Vocational, Technical and Adult Education hereby renumbers rules as follows:

SECTION 1. Chapter A-V 1 to 8, 10 and 11 are renumbered Chapters
VTAE 1 to 8, 10 and 11 respectively.

4 SECTION 2. Wherever there is a cross-reference to a section of 5 the Wisconsin Administrative Code with the designation "A-V", the 6 cross-reference shall be changed to "VTAE" by the revisor of statutes. The rules contained in this order shall take effect as provided in s. 227.026(1)(intro.), Stats.
