
TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETINGS:

ORDER

Pursuant to authority vested in the Examining Board of Architects, Professional Engineers, Designers and Land Surveyors in ss. 15.08(5)(b), 227.014(2)(a) and 443.04, Stats., s. 15.405(2), as affected by 1983 Wisconsin Act 403 and s. 443.04(1)(c) and (d), as affected by 1983 Wisconsin Act 328, the Examining Board of Architects, Professional Engineers, Designers and Land Surveyors hereby amends, repeals and recreates and adopts rules, interpreting ss. 15.405(2), 443.04, 443.04(1)(c) and (d), Stats., as follows:

SECTION 1. A-E 1.01(2) is amended to read:

A-E 1.01(2) The engineers' section ~~approves, in general,~~ shall approve all curricula in engineering that are accredited by the accreditation board for engineering and technology or equivalent curricula.

SECTION 2. A-E 1.14 is repealed and recreated to read:

A-E 1.14 APPLICATIONS FILED UNDER SS. 443.04(1)(c) or (d), STATS. An applicant who applies for registration as a professional engineer under:

(1) S. 443.04(1)(c), Stats., shall file a completed application with the board which shall include a record which specifically describes the knowledge of mathematics, the physical sciences and the principles of engineering which the applicant has acquired by professional education or practical experience.

(2) S. 443.04(1)(d), Stats., shall file a completed application with the board which shall include a statement by the applicant describing provisions of Wisconsin law which govern the practice of engineering and which concerns the design needs of people with physical disabilities.

SECTION 3. A-E 1.175 is amended to read:

A-E 1.175 EXPERIENCE IN WISCONSIN. In addition to other experience requirements in this chapter, an applicant for registration as a professional engineer under s. 443.04(1)~~(e)~~(d), Stats., shall submit evidence that the applicant has had a least six months of engineering experience in Wisconsin or has had sufficient contacts with this state to make the applicant familiar with Wisconsin engineering law and practice.


SECTION 4. A-E 3.10(1) is amended to read:

A-E 3.10(1) COMPOSITION. The rules committee of the examining board of architects, professional engineers, designers and land surveyors shall be comprised of one member from each section and ~~one~~ 2 public ~~member~~ members from ~~one~~ any 2 of the 4 sections appointed by the chairperson of the board.

The rule revisions contained in this order shall take effect on the first day of the month following publication in the Wisconsin administrative register, pursuant to s. 227.026, Stats.
