IN THE MATTER OF THE RULE RENUMBERING AND AMENDING OF) ORDER CHAPTERS OCT 1 THROUGH OCT 2 RELATING TO THE GENERAL) ADOPTING OPERATIONS OF THE OFFICE OF THE COMMISSIONER OF) RULE TRANSPORTATION)

To amend OCT 1.01; to repeal OCT 2.04(1)(a) and renumber and amend OCT 2.04(b); to renumber OCT 2.11(d).

Analysis prepared by the Office of the Commissioner of Transportation:

Section OCT 1.01 is amended and s. OCT 2.11(1)(d) is renumbered to correct typographical errors made during the revision of chapters OCT 1 and OCT 2 which became effective September 1, 1986. Section OCT 2.04(1)(a) is repealed because it is in conflict with s. 194.04(1)(b), Wis. Stats.

There is no fiscal effect anticipated from the adoption of these rules.

SECTION 1. OCT 1.01 is amended to read as follows:

OCT 1.01 COMMUNICATIONS AND DOCUMENTS ADDRESSED TO OFFICE. (1) All written communications and documents should be addressed to the Office of the Commissioner of Transportation, Hill Farms State Transportation Building, 4802 Sheboygan Avenue, P. O. Box 7957, Madison, WI 54607-7957 53707-7957.

SECTION 2. OCT 2.04(1)(a) is repealed.

SECTION 3. OCT 2.04(1)(b) is renumbered 2.04(1) and is amended to read:

(1) No application fee shall be collected for: (b) An an amended application filed pursuant to s. OCT 2.03, provided that the original authority is canceled and a new authority is substituted therefor. When a new authority is issued under this subsection a new "licensed carrier" (L.C.) number will also be issued.

SECTION 4. OCT 2.11(1)(d) is renumbered OCT 2.11(1)(a).
