

PHARMACY EXAMINING BOARD	:	AMENDING OR ADOPTING RULES

AN ORDER to create s. Phar 7.08, relating to standards for pharmacies in maintaining a medication profile record system of all drug products dispensed for a particular patient.

ANALYSIS

1985 Wisconsin Act 342 created s. 450.09(6), Stats., requiring that every pharmacy maintain a medication profile record system of all drug products dispensed for a particular patient. The statute authorizes the Pharmacy Examining Board to establish minimum standards for such systems by rule and further provides that the board's rule shall require the recording of all renewal dispensing information required by federal and state law and related rules and regulations.

The proposed rule provides an implementation date for the medication profile record system, and specifies what minimal information shall be recorded. It also contains standards for use of such systems by licensees of the board.

ORDER

Pursuant to the authority vested in the Pharmacy Examining Board in ss. 15.08(5)(b), 227.11 and 450.09(6), Stats., the Pharmacy Examining Board hereby adopts rules implementing s. 450.09(6), Stats., as follows:

SECTION 1. Phar 7.08 is created to read:

Phar 7.08 Medication profile record system. (1) Within three years of the effective date of this rule, an individual medication profile record system shall be maintained in all pharmacies for persons for whom prescriptions, original or renewal, are dispensed for outpatient use. The system shall be capable of permitting the retrieval of information. The system need not be limited to individual medication profile records.

(2) The following minimum information shall be retrievable:

(a) Patient name, or other identifying information.

(b) Address of the patient.

- (c) Birth date of the patient if obtainable.
- (d) Name of the drug product dispensed.
- (e) Strength of the drug product dispensed.
- (f) Dosage form of the drug product dispensed.
- (g) Quantity of the drug product dispensed.
- (h) Directions for use.
- (i) Retrieval designation assigned to the prescription order.
- (j) Date of all instances of dispensing, for original and renewal prescriptions.
- (k) Practitioner identification.

Note: This subsection incorporates renewal dispensing information required by federal law (21 CFR 1306.22) and state law (s. 450.11(5), Wis. Stats.).

(3) The pharmacist shall be responsible for attempting to ascertain and record any patient allergies, adverse drug reactions, drug idiosyncrasies, and any chronic conditions which may affect drug therapy as communicated by the patient or agent of the patient. If none, this should be indicated.

(4) At the time a prescription order is reviewed by the pharmacist for dispensing, the pharmacist shall review the medication profile record of the patient for the previously dispensed medication history and shall determine whether the prescription order presented should be dispensed.

(5) Medication profile records, if used as the only documentation of renewal dispensing, shall be maintained for a period of not less than 5 years following the date of the last entry. If the profile records are not used as the only documentation of renewal dispensing they shall be maintained for a period of not less than 1 year from the date of the last entry.

The rules contained in this Order shall take effect on the first day of the month following publication in the Wisconsin administrative register, pursuant to s. 227.22(2)(intro.), Stats.

INITIAL REGULATORY FLEXIBILITY ANALYSIS

The rules proposed will have some but not a significant economic impact on pharmacies, which may be small businesses as defined in s. 227.114(1)(a), Stats.

In a survey of Pharmacy Practice Profiles - Part 2 conducted by Professor Robert W. Hammel of the University of Wisconsin School of Pharmacy and Sonderegger Research Center and pharmacist Timothy L. Lobner, a pharmacy administration graduate student, patient medication profiles (other than those required for schedule II controlled substances) are already kept by about 97 percent of the survey respondents.
