# ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD REPEALING RULES

IN THE MATTER of repealing s. NR 25.07(2)(a)3.d.3) of the Wisconsin Administrative Code pertaining to commercial fishing for chubs in Green Bay and Lake Michigan

### Analysis Prepared by the Department of Natural Resources

Authorizing statutes: ss. 29.174(3), 29.33(1), 227.11(2)(a) and 227.16(2)(e) Stats.

Statutes interpreted: ss. 29.085, 29.174(2)(a) and 29.33(1), Stats.

By repealing a July 1, 1988 "sunset" date, the Order extends indefinitely a rule that allows any permittee with an individual chub quota allotment to temporarily transfer up to 50% of his or her allotted chub quota to another permittee who also has an individual chub quota allotment.

SECTION 1. NR 25.07(2)(a)3.d.3) is repealed.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on September 29, 1988.

The rules shall take effect on the first day of the month following publication in the Wisconsin administrative register as provided in s. 227.22(2)(intro.), Stats.
