ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD  
RENUMBERING AND CREATING RULES

.....  
IN THE MATTER of renumbering s. NR 45.04(3)(h) .  
and creating s. NR 45.04(3)(h)2. of the .  
Wisconsin Administrative Code pertaining to the .  
possession and consumption of intoxicating liquor . LE-60-89  
or fermented malt beverages on department of .  
natural resources water access sites .

Analysis Prepared by Department of Natural Resources

Statutory authority: ss. 227.11(2)(a) and 227.16(2)(e), Stats.  
Statutes interpreted: s. 23.11, Stats.

This rule prohibits the consumption or possession of open containers of intoxicating liquor or fermented malt beverages when on department water access sites during certain times of the year. The rule allows the department to restrict such conduct during the period from April 1 to the Saturday preceding Memorial Day. The restriction would apply only between the hours of 6:00 p.m. to 6:00 a.m. of the next day and then only on sites where posted notice is provided.

SECTION 1. NR 45.04(3)(h) is renumbered 45.04(3)(h)1.

SECTION 2. NR 45.04(3)(h)2. is created to read:

NR 45.04(3)(h)2. Liquor and malt beverages on public access sites.

During the period from April 1 to 6:00 a.m. on the Saturday preceding Memorial Day, from the hours of 6:00 p.m. to 6:00 a.m., no person may possess open containers of intoxicating liquor or fermented malt beverages or drink such beverages while on or within the boundaries of water access sites owned, under easement, leased or administered by the state of Wisconsin and under the management, supervision and control of the department when posted with notice of the restriction.

The foregoing rule was approved and adopted by the State of Wisconsin Natural Resources Board on September 28, 1989.

The rule shall take effect the first day of the month following publication in the Wisconsin administrative register as provided in s. 227.22 (2)(intro.), Stats.


