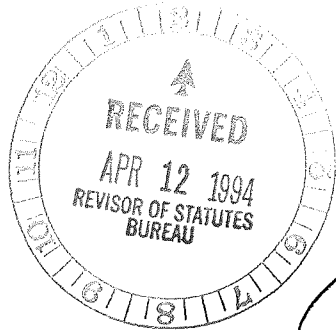

An order of the Pharmacy Examining Board to amend Phar 4.05 (3) relating to reexamination fees.

ANALYSIS

Statutes authorizing promulgation: ss. 15.08 (5) (b), 227.11 (2), 440.03 (2), 440.06 and 450.02 (3) (d), Stats.

Statutes interpreted: s. 440.06, Stats.

In this proposed rule-making order the Pharmacy Examining Board amends s. Phar 4.05 (3) as a result of rule-making by the Department of Regulation and Licensing, Clearinghouse Rule 93-113, effective December 1, 1993. In Clearinghouse Rule 93-113, the Department of Regulation and Licensing repealed and recreated s. RL 4.04 to reflect revisions to s. 440.05 (1), Stats., contained in 1993 Wisconsin Act 16. Listing of specific fees is removed from s. RL 4.04 and replaced by a rule which requires the department to maintain and make available to the public a list of current examination fees.

TEXT OF RULE

SECTION 1. Phar 4.05 (3) is amended to read:

Phar 4.05 (3) An application for reexamination shall be made on forms provided by the board. An applicant shall remit the reexamination fee ~~specified in ch. RL-4.~~

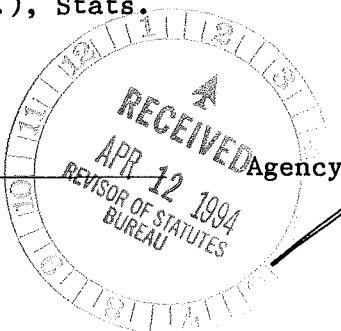



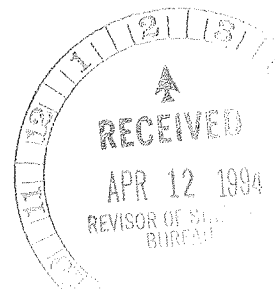
