

EXECUTIVE ORDER #277

Relating to Designation of a Valued Historical Landmark and an Architectural Masterpiece

WHEREAS, the Warner Grand Theatre building located at 212 West Wisconsin Avenue, Milwaukee, Wisconsin, was built in 1930 and first opened in 1931; and

WHEREAS, the Warner Grand Theatre was designed for Warner Bros. Theatres by the architectural firm Rapp & Rapp, renowned across the United States for its movie palace and theatre designs; and

WHEREAS, Rapp & Rapp designed the Warner Grand Theatre to be a crown jewel of the Warner Bros. Theatre chain, drawing influence from the Art Deco movement and French design; and

WHEREAS, for decades after its opening, the Warner Grand Theatre was a significant contributor to the Milwaukee entertainment scene; and

WHEREAS, as evidence of the Warner Grand Theatre's significant contribution to the cultural and architectural landscape of Milwaukee and the state of Wisconsin, the Warner Grand Theatre building is designated as a contributing building to the West Side Commercial Historic District in Milwaukee, a district recognized as a historic place in the National Register of Historic Places; and

WHEREAS, by virtue of its inclusion in the West Side Commercial Historic District, the Warner Grand Theatre is deemed worthy of preservation for its historical significance; and

WHEREAS, the Milwaukee Symphony Orchestra has acquired the Warner Grand Theatre to serve as its new concert home, continuing the building's use for the cultural benefit of Milwaukee and the state of Wisconsin;

NOW, THEREFORE, I, SCOTT WALKER, Governor of the State of Wisconsin, by the authority vested in me by the Constitution and the laws of this State, do hereby designate the grounds and improvements constituting the Warner Grand Theatre building and contiguous property acquired and incorporated into the new home for the Milwaukee Symphony Orchestra, as more particularly described on Exhibit A attached hereto, as a valued historical landmark and an architectural masterpiece, thereby making such real property and improvements a cultural and architectural landmark.
