EXECUTIVE ORDER #283

Relating to a Proclamation that the Flag of the United States and the Flag of the State of Wisconsin Be Flown at Half-Staff as a Mark of Respect for Master Sgt. Jonathan J. Dunbar, Who Lost His Life While Serving His Country

WHEREAS, on March 30, 2018, Master Sgt. Jonathan J. Dunbar, in support of Operation Inherent Resolve, died from wounds received from an improvised explosive device that detonated near his patrol in Manbij, Syria; and

WHEREAS, Master Sgt. Jonathan J. Dunbar was the son of Linda Blanchard of Bad River, Wisconsin; and

WHEREAS, for his faithful service to the people of the State of Wisconsin and the people of the United States, Master Sgt. Jonathan J. Dunbar earned numerous awards and decorations, including three Bronze Stars, four Army Commendation Medals, six Army Achievement Medals, the Afghanistan Campaign Medal with two Bronze Service Stars, the Iraq Campaign Medal with two Bronze Service Stars, the Global War on Terrorism Expeditionary Medal, the Global War on Terrorism Service Medal, the Noncommissioned Officer Professional Development Ribbon with Numeral 3, the Army Service Ribbon, two Overseas Service Ribbons, the NATO Medal, the Ranger Tab, the Combat Infantryman Badge, the Expert Infantryman Badge, the Pathfinder Badge, the Military Freefall Jumpmaster Badge, and the Parachutist Badge; and

WHEREAS, the people of Wisconsin mourn the death of Master Sgt. Jonathan J. Dunbar; and

WHEREAS, a traditional Ojibwe memorial ceremony will be held for Master Sgt. Jonathan J. Dunbar in Odanah, Wisconsin on Saturday, April 14, 2018;


NOW THEREFORE, I, SCOTT WALKER, Governor of the State of Wisconsin, by the authority vested in me by the Constitution and laws of this State and by federal law, do hereby order that the flag of the United States and the flag of the State of Wisconsin shall be flown at half-staff at all buildings, grounds, and military installations of the State of Wisconsin equipped with such flags, beginning at sunrise **Saturday, April 14, 2018**, and ending at sunset on that date.
