AN ACT to provide for the compensation of the present officers of the Legislative Assembly.

Be it enacted by the Council and House of Representatives of the Territory of Wisconsin:

SEC. 1. That there shall be allowed, at the present session Compensation.

To the president of the Council, and speaker of the House of The president Representatives, each three dollars per day in addition to their pay as members, for each day they shall have actually performed the duties of their respective offices;

Compensation tion, when due to the officers of the Council, shall be certified by the president thereof, and attested by the secretary; and the compensation that may be due to the officers of the House of Representatives, shall be cortified by the speaker thereof, and attested by the chief clerk; which certificates, when made out as aforesaid, shall be sufficient evidence to the secretary of the territory, or the fiscal officer, appointed by the Legislativo Assembly, of each person's claim, and upon which he is authorised to make payment.

AN ACT to prescribe the number, duties and compensation of the officers of the Legislative Assembly, and for other purposes.

Be it enacted by the Council and House of Representatives of the Territory of Wisconsin:

The officers of the Council, shall consist of a pres-The number of ident (who shall be a member of said body,) a secretary, a doorkeeper, (who shall also perform the duty of sergeant-atarms,) a messenger and two transcribing clerks; and the officers of the House of Representatives, of a speaker, (who shall be a member of said body) a chief clerk, a doorkeeper, (who shall perform the duty of sergeant-at-arms) an assistant doorkeeper, a messenger and two transcribing clerks: one of said clerks in each of the Houses may be required by the secretary or clerk to perform the duties of assistant.
