AN ACT to prescribe the number, duties and compensation of the officers of the Legislative Assembly, and for other purposes.

Be it enacted by the Council and House of Representatives of the Territory of Wisconsin:

officers of the legislative assembly.

The officers of the Council, shall consist of a pres-The number of ident (who shall be a member of said body,) a secretary, a doorkeeper, (who shall also perform the duty of sergeant-atarms,) a messenger and two transcribing clerks; and the officers of the House of Representatives, of a speaker, (who shall be a member of said body) a chief clerk, a doorkeeper, (who shall perform the duty of sergeant-at-arms) an assistant doorkeeper, a messenger and two transcribing clerks: one of said clerks in each of the Houses may be required by the secretary or clerk to perform the duties of assistant.

The election of the said officers shall be by ballot How & when of the respective Houses at the opening of each session of the to be elected. Legislative Assembly: Provided, That the secretary of the Council and the chief clerk of the House, shall be elected annually at the commencement of the regular annual sessions of the Legislature. In all cases of elections under this section, it shall require a majority of the votes given, to determine a choice.

It shall be the duty of the secretary of the Coun- Duties of the Sec. 3. cil, and chief clerk of the House, to keep correct journals of secretary an chief clerk. the proceedings of their respective Houses, to have the custody of all records, accounts and other papers committed to them, and generally to perform such other duties, as shall be assigned them by their respective Houses. It shall also be the duty of the the said secretary and chief clerk, to prepare for publication, at the close of each session, the journals of their respective Houses, and to affix an index thereto; for which service they shall be allowed such compensation, as the Legislative Assembly may from time to time determine.
