

ated, to the lieutenant governor and to each member of the senate and assembly, the sum of five dollars, and twenty-five dollars each to the chief clerks of the senate and assembly, being the amount allowed them by law for stationery, and the sum of fourteen hundred and eighty-two dollars to pay the mileage of the lieutenant governor and members of the senate and assembly, to be paid to each of them by the treasurer, on the production of a certificate of the presiding officer of each house, countersigned by the chief clerk of each house, which certificate shall be a sufficient voucher for said treasurer; and there is also hereby appropriated, to be paid upon the certificate of the secretary of state as aforesaid, out of any money now in the treasury, the sum of fifty-five dollars to the lieutenant governor, and fifty-five dollars to each member of the senate and assembly, as part compensation for their services at the present session of the legislature, and to each of the revisers of the laws the sum of one hundred dollars as part pay for their services.

Mileage.

SEC. 2. There is also hereby appropriated, to be paid upon the certificate of the secretary of state, as aforesaid, out of any moneys now in the treasury, to each of the chief clerks of the senate and assembly, the sum of one hundred and twenty-five dollars; and to the sergeant at arms of the senate and assembly each the sum of one hundred dollars, in part pay for their services and those employed under them; which said amounts, when so paid by the treasurer to the persons above named, they shall execute to said treasurer sufficient vouchers therefor.

- Chap 24. An Act to provide for the payment of the heirs of the late Thomas P. Burnett, deceased, for reporting the decisions of the Supreme Court of the Territory of Wisconsin.

THE People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Appropriation to heirs of T. P. Burnett.

SECTION 1. The sum of seven hundred and fifty dollars is hereby appropriated to the heirs of the late Thomas P. Burnett, deceased, to be drawn by the legal guardian of the heirs of the said deceased on demand made upon the treasury of the state, the same being the amount appropriated by law approved March 11th, 1848, for services as Reporter of the Supreme Court of Wisconsin Territory, and the same being in full for all services in preparing said Reports for publication.

- Chap 25. An Act to authorize the Presbyterian church in Platteville, Grant county, to change its name and form of government.

THE People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

May change name.

SECTION 1. That it shall and may be lawful for the members of the Presbyterian church in the town of Platteville, in Grant county, to change their name and form of government to that of a Congregational church.

May lease, &c.

SEC. 2. That the trustees of the aforesaid Presbyterian church be and they are hereby empowered to sell, lease, or otherwise dispose of the property belonging to said church, and to make, execute, and deliver to the trustees of the Congregational church, when duly chosen, deeds therefor, under their hands and seals: *Provided*, that a majority of the members of the said Presbyterian church concur in such transfer by their votes cast at a meeting called for the purpose, of which public notice shall be given from the pulpit, at least two Sabbaths next preceding the time of holding such meeting.

Successors in law.

SEC. 3. That the said Congregational church, when formed as hereinbefore provided, shall be the successor in law to the said Pres-
