Chap 202

*The people of the State of Wisconsin represented in Senate and Assembly do enact as follows:*

SECTION 1. There is hereby appropriated to Messrs. Weed & Eberhard, out of any money in the state treasury not otherwise appropriated, the sum of one hundred and five dollars and fifty cents (\$105 50) in full of account against the state, from the seventeenth day of January, A. D. 1852, to the fourth of March inclusive, in the same year.

An Act to cede the jurisdiction of the State of Wisconsin over the land therein described to the United States.

Chap 203

*The people of the State of Wisconsin represented in Senate and Assembly, do enact as follows:*

SECTION 1. That the jurisdiction of the state of Wisconsin over all that tract of land in the county of Manitowoc, in said state, which is described as follows, to wit: the light house property at or near Two Rivers, in the county and state aforesaid; the site, if selected in the village, to be limited to four lots, and if out of the village, to ten acres of land, be and the same is hereby ceded to the United States, for the purpose of erecting and maintaining a light house on the same: *Provided*, That this act shall in no manner take away or interfere with the jurisdiction of this state for the purpose of serving or executing any legal processes.

SEC. 2. This act shall take effect from and after its passage.

**Chap 204** An Act to authorize and require the town superintendent of Hartford to pay a certain amount of money to school district number four, and to other districts in said town.

*The people of the State of Wisconsin represented in Senate and Assembly, do enact as follows:*

Authorized to  
apportion money

SECTION 1. The town superintendent of the town of Hartford, Washington county, is hereby authorized and required to apportion, from any money which shall be received by him for school purposes, for the year one thousand eight hundred and fifty-two, to school district number four, in said town, and pay, on the order of the treasurer of said district and of the treasurer of other districts herein named, the amount of money which should have been apportioned in the year one thousand eight hundred and fifty, to said districts number four, and to other districts in said town that made returns in the same manner, as shown by the returns made to the said town superintendent by the clerks of said school district number four and other districts above named, in the year one thousand eight hundred and forty-nine.

SEC. 2. This act shall take effect from and after its passage.
