An Act to appropriate to John White the sum therein named.

*The people of the State of Wisconsin represented in Senate and Assembly, do enact as follows:*

SECTION 1. That there is hereby appropriated to John White the sum of one hundred and twenty-five dollars, in full for boarding Patrick Marony, Seth Rogers, Peter Duffy, Ambrose W. Barnard, and John Myers, state prisoners, from January 1st, to January 12th, 1852, and for incidental expenses in removing state prisoners from Milwaukee to Waupun, and for service of pardons and return of certificates to Madison, for David Bonham, Margaret Drum, Augustus Lawson, Balze Conrad, and Joseph Conrad, out of any money in the state treasury not otherwise appropriated.

## Chap 346

An Act to appropriate to M. N. Moulthrop, late sheriff of Winnebago county, a certain sum of money.

SECTION 1. There is hereby appropriated, out of any money in the treasury not otherwise appropriated, to M. N. Moulthrop, late sheriff of Winnebago county, the sum of twenty-two dollars and fifty cents, in full for fees in the case of the State vs. Winnebago county.

count against the state for serving papers by order of the attorney general, from the first of December, 1851, to the first of March, 1852, to be paid out of any money in the state treasury not otherwise appropriated.
