laws of 1861, is hereby amended, by inserting after the word "notice," in the twelfth line of said section, the following: "*provided*, the foregoing enactment shall not affect the legality of any publications for the sale of unredeemed lands that may be advertised in any newspaper published in Douglas [Douglass] county."

SECTION 2. This act shall take effect and be in force from and after its passage.

CHAPTER 10.

[Published February 7, 1862.]

AN ACT to extend the time for the collection of taxes in the county of Shawanaw.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :

Extended to
March 3.

SECTION 1. The time for the collection of taxes, except state taxes, in the county of Shawanaw, is hereby extended to the first Monday of March next.

SECTION 2. This act shall take effect and be in force from and after its passage.

CHAPTER 11.

[Published February 8, 1862.]

AN ACT to amend section 31 of chapter 134 of the revised statutes, entitled "of executions and proceedings supplementary thereto."

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :

Exemptions not
extended to non-
residents.

SECTION 1. Section thirty-one of chapter one hundred and thirty-four of the revised statutes, is hereby

amended, by adding thereto a new paragraph, as follows: "*provided, however, that the exemptions provided for and embraced in subdivisions seven, eight, nine and ten of this section, shall extend only to debtors having an actual residence in this state.*"

SECTION 2. This act shall take effect and be in force from and after its passage.

CHAPTER 12.

[*Published February 8, 1862.*]

AN ACT to change the time of holding courts in the county of Calumet, in the fourth judicial circuit.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. That, hereafter, the June term of the circuit court in and for the county of Calumet, in the fourth judicial circuit of this state, shall be held on the fourth Monday of June, in each year. June term.

SECTION 2. All writs, summons, process, indictments, recognizances, notices, motions, orders and other proceedings, made returnable on the third Monday of June next, shall be returnable the day above fixed; and all adjournments, appearances, continuances, motions or notices of any proceedings whatever, in the circuit court of said county, made or taken to the said third Monday of June next, shall be held and taken for the time herein provided for the term of said court. Return of writs,
&c.

SECTION 3. All acts and parts of acts conflicting with the provisions of this act, are hereby repealed. Repeal.

SECTION 4. This act shall take effect and be in force from and after its passage and publication.
