

Larkin, on lots one, two and three, in block number thirty, in the fifth ward of said city, being three hundred dollars of principal, and the interest thereon; also, the amount remaining unpaid on two notes executed by said city to M. Neubauer, for seven hundred dollars each, on or about the eleventh day of February, 1860, in part payment of the purchase money for lots one and four, in block twelve, in Kneeland's addition, in the ninth ward, being fourteen hundred dollars and the interest thereon; which additional tax shall be levied, assessed and collected at the same time and in the same manner as, and shall be included in and shall form a part of, the tax which shall be levied, assessed and collected for general city purposes, for the said year one thousand eight hundred and sixty-two.

SECTION 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 307.

[Published April 14, 1862.]

AN ACT to authorize the common council of the city of Milwaukee to levy a tax on [the] taxable property in the second and sixth wards of the city of Milwaukee, to pay principal and interest of bonds issued to David Knab, January 1, 1859.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

**Tax for payment of bonds issued to David Knab.**

SECTION 1. The common council of the city of Milwaukee is hereby authorized and directed to levy a tax on all the taxable property in the second and sixth wards of the city of Milwaukee, in addition to the general ward tax for each year in those wards, sufficient to pay the principal and interest, at seven per cent. from the first day of January, 1862, of twelve certain ward bonds issued to Daniel Knab, January 1, 1859, for grading and filling the public park situated in the said second ward, and belonging to the second and sixth wards of said city.

**Limit to tax.**

SECTION 2. One-half of the tax provided to be levied in section one of this act, shall be levied on the taxable

property of the second ward, and one-half shall be levied on the taxable property of the sixth ward of said city of Milwaukee, and shall not exceed the sum of three thousand dollars, and interest on the same at seven per cent. per annum, from January 1, 1862, in each of said second and sixth wards.

SECTION 3. The tax provided for in sections one and two of this act, shall be levied as follows: A tax on all the taxable property in said second ward of the city of Milwaukee, shall be levied in the year 1862, sufficient to pay five hundred dollars of the amount due for principal and interest on the said sum of three thousand dollars of bonds of the second ward of said city of Milwaukee, so issued to David Knab; and thereafter from year to year, a tax shall be levied on all the taxable property in said second ward, sufficient to pay five hundred dollars of the amount which may remain unpaid for principal and interest of said sum of three thousand dollars, until the whole of said sum of three thousand dollars and interest, shall be fully paid; and a like tax shall be levied in the same manner and form as is above prescribed, for the second ward, on all the taxable property in the sixth ward of said city of Milwaukee, for the year 1862, and thereafter, from year to year, to pay the three thousand dollars and interest of said bonds, issued to said David Knab by said sixth ward. How to be levied

SECTION 4. The tax provided for by this act, shall be levied, assessed and collected at the same time and in the same manner and form as the state, county and city taxes are levied, assessed and collected in the city of Milwaukee, and shall be paid over by the city treasurer of Milwaukee, when collected, to said David Knab, annually, pursuant to this act. When to be collected.

SECTION 5. So much of any act heretofore passed as conflicts with this act, is hereby repealed. Repeal.
