

CHAPTER 142.

[Published April 14, 1863.]

AN ACT to appropriate to the Wisconsin state reform school the sum of four thousand dollars.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. The sum of four thousand dollars is hereby appropriated out of any money in the treasury not otherwise appropriated, to the Wisconsin state reform school, for the expenses and improvements of the ensuing year. \$4,000 for improvements.

SECTION 2. This act shall take effect and be in force from and after its passage.

CHAPTER 143.

[Published April 15, 1863.]

AN ACT to appropriate to the Wisconsin institute for the education of the deaf and dumb, and the trustees thereof, the sums of money therein named.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. The sum of thirteen thousand five hundred dollars is hereby appropriated out of any money in the treasury not otherwise appropriated, to the Wisconsin institute for the education of the deaf and dumb, as current expenses for the ensuing year. \$13,500 for current expenses.

SECTION 2. The sum of three hundred dollars is hereby appropriated out of any money in the treasury not otherwise appropriated, to the Wisconsin institute for the education of the deaf and dumb, for the expenses of the indigent deaf and dumb. \$3,000 for expenses of indigent.

SECTION 3. The sum of two hundred dollars is hereby appropriated out of any money in the treasury not otherwise appropriated, to the trustees of the Wisconsin institute for the education of the deaf and dumb, \$200 for drainage.

for drainage purposes upon the grounds of the institute.

SECTION 4. This act shall take effect and be in force from and after its passage.

CHAPTER 144.

[Published April 15, 1863.]

AN ACT to appropriate to the Wisconsin state hospital for the insane, and to the trustees thereof, the sum of thirty-one thousand dollars.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :

\$30,000 for current expenses.

SECTION 1. The sum of thirty thousand dollars is hereby appropriated to the Wisconsin state hospital for the insane, out of any money in the treasury not otherwise appropriated, for current expenses of the ensuing year.

\$1,000 for improvement of grounds.

SECTION 2. The sum of one thousand dollars is hereby appropriated to the trustees of the Wisconsin state hospital for the insane, for the purpose of improving the hospital grounds.

SECTION 3. This act shall take effect and be in force from and after its passage.

CHAPTER 145.

[Published April 15, 1863.]

AN ACT to appropriate to the Wisconsin institute for the education of the blind, and to the trustees thereof, the sum of fourteen thousand dollars.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :

\$12,000 for current expenses.

SECTION 1. There is hereby appropriated the sum of twelve thousand dollars, out of any money in the
