AN ACT to extend the time for the collection of taxes in the town. of Fox Lake, in the county of Dodge.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. The time for the collection of taxes in April 1. the town of Fox Lake, in the county of Dodge, is hereby extended until the first day of April, A. D. 1865; and the treasurer of the said town of Fox Lake is here- Power of these by authorized to proceed in the collection of the taxes urer. now in his hands for collection, in the same manner and with the same authority, until the said first day of April, as now provided by law for the collection of taxes: provided, that nothing in this act shall be construed as extending the time for the payment to the county treasurer of the state tax of said town.

Section 2. This act shall take effect and be in force from and after its passage.

CHAPTER 111.

AN ACT relating to a state road in Manitowoo county, and amendstory of section one of chapter 218 of the local [general] laws of 1861, entitled "an act to provide for the laying out of a state road from the village of Manitowoc, in the county of Manitowoc, by the way of the village of Kiel, in Manitowoc county, to the village of Taycheedah, in the county of Fond du Lac," and of section two of chapter 227 of the local [general] laws of 1868, amendatory thereof.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. That section one of chapter two hundred and eighteen of the local [general] laws of 1861, as amended by section one, chapter two hundred and twenty-seven of the local [general] laws of 1863, be and

the same is hereby amended, so as to read as follows: "Henry F. Belitz, of Manitowoc county, Ferdinand Beummele, of Sheboygan county, and Joseph Wagner, of Fond du Lac county, are hereby appointed commissioners to lay out and establish a state road from the village of Kiel, in the county of Manitowoc, to the village of Taycheedah, in the county of Fond du Lac: provided, that no liability be created against the state."

Asta declared

SECTION 2. That the acts of the said commissioners in surveying and laying out a road under and in pursuance of the provisions of the said acts of which this is amendatory, from the said village of Kiel to the said village of Manitowoc, be and the same are hereby declared null and void.

SECTION 8. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 112.

AN ACT to detach Dallas county from the eleventh judicial circuit, and attach the same to the eighth judicial circuit.

The people of the state of Wisconsin, represented in senats and assembly, do enact as follows:

Drinshol and attacked: SECTION 1. The county of Dallas is hereby detached from the eleventh judicial circuit, and the same is attached to the eighth judicial circuit.

SECTION 2. All acts or parts of acts inconsistent with this, are hereby repealed, and this act shall take effect on and after its passage.
