CHAPTER 475.
[Published May 81, 1866.]
AN ACT to authorize Jesse Spalding to build, keep and maintain a boom on the Monomonee river, below Chappes' rapids, in the county of Oconto, and state of Wisconsin.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Section 1. Section one of chapter one hundred and amondmant. twenty-seven of the private and local [general] laws of the year 1865, entitled "an act to authorize Jesse Spalding to build, keep and maintain a boom on the Monomonee river, below Chappes' rapids, in the county of Oconto, and state of Wisconsin," is hereby amended, 80 as to read as follows: "Jesse Spalding, Isaac Anthoritr to Stephenson and S. M. Stephenson, and their associates, keep and maintain a boom at such point between the head of the old water-mill rapids and the foot of Chappes' rapids, on the Monomonee river, in Oconto county, in the state of Wisconsin, as shall be eligible, and to erect piers to secure the same to and connect the same with the Wisconsin shore of said river, and to connect the same with the Michigan shore of said river, as prescribed in an act of the legislature of the state of Michigan, granting the said Jesse Spalding the right to build [a] boom across the Menomonee Not to obstruct river as aforesaid: provided, such boom shall be so con-

Penalty fce injury to. structed as to admit of the passage of boats and other craft, and loge, timber, lumber and other merchandise belonging to other persons, through the same."

Section 2. Any person who shall break or destroy said boom, or loose the same from its moorings, or willfully injure the same, or any of the piers or other appurtenances thereto, shall be liable to the owners in treble the damage sustained, in an action of trespass, and shall be further liable to all the penalties prescribed by the general laws of this state for trespass.

Section 3. This act shall take effect be in force from and after its passage.
