

## CHAPTER 14.

[Published March 2, 1867.]

AN ACT to amend chapter 275 of the general laws of 1863, entitled "an act to provide for printing an additional number of the report of the superintendent of public instruction."

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

5,000 extra  
copies to be  
printed.

SECTION 1. Section 1 of chapter 275 of the general laws of 1863 is hereby amended, so as to read as follows: "Section 1. When the annual report of the superintendent of public instruction shall be delivered to the public printer by the governor, in addition to the number of copies now authorized by law, the public printer shall print five thousand copies of said report, which shall be folded and stitched in pamphlet form, for the use of the superintendent of public instruction, to be by him distributed among the town and district clerks of the state."

Repealed.

SECTION 2. All acts and parts of acts conflicting with this act, are hereby repealed.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 15.

[Published March 2, 1867.]

AN ACT to authorize the state treasurer to settle with stockholders and bondsmen of insolvent banks for balances due the state on circulating notes of said banks, held by the state when the banks failed.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

Authority to  
treasurer.

SECTION 1. The state treasurer is hereby authorized to settle with the stockholders and bondsmen of the insolvent banks of this state for the balances due upon the circulating notes of such banks, held by the

said treasurer at the time of the failure of such banks, and which remain due thereon, after the application of the proceeds of the sales of the securities deposited for the redemption thereof, upon such terms as he may deem best for the interest of the state, and upon such settlement to give full releases for any balances due upon such circulating notes to said stockholders or bondsmen.

SECTION 2. This act shall take effect immediately upon its passage and publication.

## CHAPTER 16.

[Published March 2, 1867.]

AN ACT to provide for the purchase of Webster's dictionary for the supply of school districts of the state.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. The state superintendent of public instruction, with the consent and approval of the governor, is hereby authorized to purchase, on behalf of the state, one hundred copies of Webster's unabridged dictionary, edition of 1864, at a cost not exceeding eight dollars per copy. State superintendent to purchase.

SECTION 2. Such dictionaries when purchased shall be distributed by the state superintendent, on receipt of the affidavit in due form (which shall be kept in his office,) of any district clerk or city superintendent of schools, that such district or city, or any public school or department in the public schools thereof, has not yet been supplied by the state with a copy of said dictionary, sending one dictionary for each public school or department thereof taught therein. How to be distributed.

SECTION 3. Such dictionaries when received by the several districts in this state, shall be considered as belonging to the libraries of the districts, and shall be subject to the same laws and regulations as other library books; but during the time a school is taught
