

and Bayfield, and towns number thirty-nine (39) and 40 north, of range one (1) east, in Chippewa county, are hereby constituted and created a lumber district, to be known and called lumber district number eleven (11).

SECTION 2. Said lumber district number eleven (11) shall be subject to the provisions of chapter one hundred and sixty-seven (167), of the general laws of 1864, entitled, "An act to establish lumber districts in this state, and to regulate the traffic in logs, timber and lumber in said districts;" and also to the provisions of chapter fifty-seven (57), of the general laws of 1866, amending said chapter one hundred and sixty-seven (167), of the general laws of 1864.

District to be subject to chap-167, (G. L. 1864.

SECTION 3. The inspector of said lumber district number eleven (11) shall keep his office at the village of Ashland, in the county of Ashland and state of Wisconsin.

Inspector to keep office at Ashland.

SECTION 4. All laws and parts of laws inconsistent with the provisions of this act are hereby repealed, and this act shall take effect and be in force from and after the passage and publication thereof.

Conflicting acts repealed.

## CHAPTER 243.

[Published March 25, 1875.]

AN ACT to vacate the cemetery located in the third ward of the city of Madison, and to provide for the removal of the dead buried therein, to the Forest Hill Cemetery, owned by said city.

*The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. That the plat of the cemetery located upon block one hundred and eighty in the city of Madison, is hereby vacated, and it shall be unlawful hereafter to use said cemetery or any lot or part of lot therein for the purpose of burying the dead therein, and it shall be lawful for the city of Madison to sell and convey the same or make such other use or disposition of said cemetery grounds, after the removal from the same of the dead buried therein, as hereinafter provided, as the common council of said city may designate or appoint.

Cemetery plat vacated.

Bodies to be removed after notice shall have been given.

SECTION 2. The bodies interred in said cemetery grounds so vacated shall be removed to the Forest Hill Cemetery, owned by said city, and buried in lots therein hitherto undisposed of, corresponding in size and value, as near as may be, with the lots in which said bodies are now interred; but before any bodies shall be removed under the authority and direction of the common council of said city as hereinafter provided, notice shall be given by the mayor of said city and commissioners of said Forest Hill Cemetery, by publishing the same in the *State Journal* and the *Madison Democrat* for twelve successive weeks, at least once in each week, to the owners of the lots in said cemetery so vacated, to select lots in said Forest Hill Cemetery in lieu thereof, and to remove their dead from said cemetery in said third ward of Madison; and that on a failure to comply with such notice by said lot owners, the said city will, under and by direction of its common council, by ordinance passed for that purpose, provide for the removal and remove the said bodies. When any such owner or owners shall not select new lots as aforesaid [and] remove such dead bodies as aforesaid from said third ward cemetery, it shall be lawful for the common council of said city to provide by ordinance for removing, and for said city under the authority of the same, and of this act, to remove such dead bodies to and bury them in said Forest Hill Cemetery, and to remove all grave stones and monuments and place them at the proper graves in said Forest Hill Cemetery in the same manner as they now are erected and placed, and all such removals and re-burials shall take place and be performed under the direction of the mayor of said city and the superintendent of said Forest Hill Cemetery, and at the expense of the city of Madison.

Expense of removals to be paid by city.

Lot owners in cemetery vacated to be entitled to lots of equal value in Forest Hill cemetery.

SECTION 3. Every holder of a lot in the cemetery hereby vacated, by deed, use, or the payment of the price thereof, shall, on releasing the same to said city, be entitled to select and receive a deed therefor, of a lot in said Forest Hill Cemetery of equal size and value, as near as may be, with the lot so vacated or released, for burial purposes, free of charge; and the lot holders in the said third ward cemetery are hereby authorized to release their right and interest in and to such lots to the city of Madison, which release, after the expiration of twelve weeks after the date of such release, shall give the city the right to remove

such dead bodies as are buried therein in the manner specified in this act.

SECTION 4. All and singular the provisions of the city charter of the city of Madison, and all acts amendatory thereof and supplementary thereto, and all and singular the ordinances and police regulations of said city, shall extend over and apply to said Forest Hill Cemetery so far as it may be necessary to protect, improve and preserve the same and secure the rights and interests of lot-owners therein, and the common council of said city shall have power and authority to pass such further or other ordinances as shall be necessary to accomplish the purposes in this section specified.

Authority of city of Madison to extend over Forest Hill cemetery.

SECTION 5. This act shall be liberally construed in all courts and places, and shall take effect and be in force from and after its passage and publication.

Act to be liberally construed.

## CHAPTER 244.

AN ACT to legalize the acts of the administrators of George H. Dartt in laying out and platting an addition to the village of North Montello.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. The acts of Josiah H. Dartt and Justus N. Dartt, administrators of the estate of George H. Dartt, in laying out, platting, and recording an addition to the village of North Montello, on the southwest quarter of section nine, town fifteen north, range ten east, are hereby declared to be legal and valid for all purposes.

Acts legalized.

SECTION 2. This act shall take effect and be in force from and after its passage.
