

right to use the water supplied by such corporation, or such portion thereof as it may desire, upon such terms and conditions as may be agreed upon by such corporation and the authorities of such city or village. Every such corporation heretofore organized shall continue to enjoy the rights given by the law under which it was formed.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 212.

AN ACT relating to the price of swamp and overflowed lands in Shawano county.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. The commissioners of public lands are hereby authorized, in their discretion, to reduce the price of all swamp and overflowed lands, now owned by the state in Shawano county, to the uniform price of seventy-five cents per acre: *provided*, that the above reduction shall not apply to any of the normal school lands or lands now under contract, and which may hereafter become forfeited to the state, until the expiration of two years after such forfeiture, with the unpaid taxes added thereto.

Seventy-five cents per acre.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 213.

AN ACT to authorize Charles D. Wescott, Mathias Miller and H. M. Loomer to construct and maintain a dam across Wolf river, in Shawano county.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Charles D. Wescott, Mathias Miller and H. M. Loomer, and their associates and assigns, are hereby authorized to erect and maintain a dam

Dam, mills and machinery.

across Wolf river, in Shawano county, at a point on the northeast quarter of section twenty-five, in township twenty-seven north, of range fifteen east; and to erect and maintain mills, machinery and necessary appendages to enable them to use the water of said river for hydraulic and boomage purposes.

Slides and
sluiceways.

SECTION 2. The aforesaid persons, their associates and assigns, shall build suitable slides or sluiceways in said dam for running logs and timber over the same, and shall keep the same in repair. The same shall be kept open at all times when said river is at a driving stage and there are logs and timber to run over said dam. The said Charles D. Wescott, Mathias Miller and H. M. Loomer, and their associates and assigns, may erect and maintain booms for the sorting of logs passing into the mill-pond hereby authorized to be created: *provided*, that said booms shall be constructed so as to allow free passage of logs or lumber.

Authority of
owners.

SECTION 3. The control of said dam, slides or sluiceways shall belong to the said Charles H. Wescott, Mathias Miller and H. M. Loomer, their associates and assigns, but subject always to the provisions of this act.

SECTION 4. The dam so erected shall be subject to all the provisions of the revised statutes of 1878, so far as the said revised statutes may apply to dams, in like manner as if such provisions were incorporated in this act.

Repealed.

SECTION 5. Any and all charters granted by the legislature heretofore, to build and maintain a dam across Wolf river at the same place as heretofore mentioned, are hereby repealed.

SECTION 6. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 214.

AN ACT authorizing justices of the peace, elected in the several wards of the city of Madison to keep an office and to perform their duties in any part of said city.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Office in any
part of city.

SECTION 1. The justices of the peace elected in the several wards of the city of Madison, may keep
