CHAPTER 21.

AN ACT to authorize Jes. Erickson and E. C. Manger to maintain a boom in Kewaunee river, in Kewaunee county.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Location of dam.

SECTION 1. Jes. Erickson and E. C. Manger, their successors or assigns, are hereby authorized to maintain and keep up a boom for the purpose of holding logs in and along the Kewaunee river, for the term of ten years, along the north boundary of lot number six, section eighteen, town twenty-three, range twenty-five east, in Kewaunee county.

SECTION 2. The said Jes. Erickson and E. C. Manger, their successors or assigns, shall leave a suitable passage for logs, lumber or timber, so as not to obstruct the navigation of said river.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 22.

AN ACT to amend chapter two hundred and eighty-four of the private and local laws of 1866, entitled an act to incorporate the Eau Claire lumber company.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Capital stock not to exceed three million dollars.

SECTION 1. Section two of chapter two hundred and eighty-four of an act entitled an act to incorporate the Eau Claire lumber company, approved April 6, 1866, is hereby amended by striking out the words "five hundred thousand" where they occur in said section, and insert in lieu thereof the words "three millions of," so that said section as amended will read as follows: Section 2. The capital stock of said company shall be such a sum as the board of director

shall fix, and the same may from time to time be enlarged by resolutions of the board of directors to any amount not exceeding three millions of dollars, and shall be divided into shares of one hundred dollars each, and such shares shall be transferable upon the books of the company only in such manner as the by-laws of the company shall direct.

CHAPTER 23.

AN ACT to provide for the purchase of Webster's unabridged dictionaries.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. The state superintendent of public instruction is hereby authorized and directed to purchase, on behalf of the state, six hundred copies of the latest edition of Webster's unabridged dictionary, at a cost, delivered at his office, not to exceed seven dollars per copy.

Purchase of six hundred copies authorized.

SECTION 2. The said dictionaries, when procured, shall be delivered in accordance with the provisions of section five hundred and nine of the revised statutes.

Distribution of same.

SECTION 3. The state superintendent of public instruction is hereby authorized to obtain Webster's unabridged dictionaries, to be sold to members of the legislature, the employes of the same and official persons connected with the state departments, in sufficient number to furnish not exceeding one copy to each such person at the price paid for the same.

Additional copies may be purchased.

SECTION 4. There is hereby appropriated out of the general fund a sum sufficient to pay for the dictionaries above provided for.

SECTION 5. This act shall take effect and be in force from and after its passage and publication.
