### CHAPTER 288.

AN ACT to create the fourteenth judicial circuit.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

Fourteenth  
judicial circuit  
organized.

SECTION 1. The counties of Door, Brown, Oconto and Marinette shall constitute the fourteenth judicial circuit.

Terms.

SECTION 2. The general term of the circuit court for the fourteenth judicial circuit shall be held as follows: In the county of Door, Tuesday after first Monday in February, Tuesday after first Monday in September. In the county of Brown, the second Monday in January (special), the second Monday in April and the second Monday in October. In the county of Marinette, the second Monday in June and the third Monday in November. In the county of Oconto, the fourth Monday in May and the fourth Monday in September. Every term in the counties of Brown, Oconto and Marinette shall also be a special term for the whole judicial circuit.

Election of  
judge.

SECTION 3. There shall be held in the fourteenth judicial circuit on the first Tuesday in May next, an election for judge of said circuit. Said election shall be held and conducted, and returns thereof made, and the result canvassed and declared in the same manner as now provided by law, for the election of judges of the circuit courts, and all laws applicable thereto, shall apply to the election of judge provided for in this act.

Term of office.

SECTION 4. The term of office of the judge of the fourteenth judicial circuit shall commence on the first Monday in January, 1884, and until that time the judge of the tenth judicial circuit shall continue to hold courts, in the several counties

named in section 1 of this act, in the same manner and at the same time, and with the same force and effect, as if this act had not been passed.

SECTION 5. All laws, so far as they conflict with the provisions of this act are hereby repealed. From and after the first Monday in January, 1884, the general terms of the circuit court for the tenth judicial circuit, shall be held as follows: In the county of Outagamie on the third Monday in April and the second Monday in October. In the county of Shawano on the first Tuesday in June and the second Tuesday in December. In the county of Langlade on the second Tuesday in January and the first Tuesday in September. In the county of Florence on the first Tuesday in March and the third Tuesday in September. In the county of Outagamie a special term for the whole circuit shall be held on the first Tuesday in February, at which, any and all business may be done, arising or pending in any county of said circuit, which might be done at a general term for the county in which such business arises, or is pending, not requiring the intervention of a jury. Every general term in the counties of Outagamie and Langlade shall be a special term for the whole judicial circuit.

Repealed.

Terms in the tenth judicial circuit, when held.

SECTION 6. This act shall take effect and be in force from and after its passage and publication. Approved April 2, 1883.

### CHAPTER 289.

AN ACT to authorize E. R. Urquhart, Peter Doyle, Joseph Brucher and W. Van Noslitz, their heirs and assigns, to build and maintain a dam on Little Black river, in the county of Taylor, Wisconsin.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. E. R. Urquhart, Peter Doyle, Joseph Brucher and W. Van Noslitz, their successors and assigns, are hereby authorized to build and maintain a dam on Little Black river, in the county of Taylor, Wisconsin, upon lands owned by themselves, on the southwest quarter ( $\frac{1}{4}$ ) of the southwest quarter ( $\frac{1}{4}$ ) of section number one (1), in township number thirty (30) north of range number one (1) east, and otherwise improve said
