## CHAPTER 228.

AN ACT to amend chapter 89, of the laws of 1883, entitled, "an act for the preservation of fish in certain lakes and streams of Dane county."

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*

Preservation of  
fish in lakes in  
Dane county.

SECTION 1. The first section of chapter 89, of the laws of 1883, is hereby amended so as to read as follows: Section 1. No person shall take, catch or kill, or attempt to do so, any fish of any kind, except minnows, suckers or whitefish, from the lakes in Dane and Rock counties, known as Kegonsa, Wingra, Waubesa, Monona, Mendota

and Koshkonong, or from any stream or waters in said counties connected therewith, except by the common hook and line. No person fishing through the ice on any of said lakes or waters, shall use more than three hooks and lines at one time.

SECTION 2. This act shall take effect from and after its passage.

## CHAPTER 229.

AN ACT to detach certain territory from the towns of Pine River and Ackley, in Lincoln county, and erect the town of Eagle River.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. All of the following described territory in Lincoln county, to wit: Towns thirty-eight (38), thirty-nine (39), forty (40), forty-one (41), forty-two (42) and forty-three (43) north, of range nine (9) east; and towns thirty-eight (38), thirty-nine (39), forty (40), forty-one (41), forty-two (42) and forty-three (43) north, of range ten (10) east, are hereby detached from the towns of Pine River and Ackley, in the county of Lincoln, state of Wisconsin, and the same shall constitute the town of Eagle River.

Authorized to detach certain territory.

SECTION 2. The said town of Eagle River is hereby created and established with all rights, powers and privileges by law granted to and possessed by other towns of this state, and subject to all the general laws prescribed for the government of such towns.

Town created.

SECTION 3. The first election of town officers of said town of Eagle River, shall be held on the first Tuesday of April, A. D. 1885, at the store of Scott and Stewart, in the village of Eagle River, and the electors of said town shall, at the opening of the polls, elect the clerk and inspectors of election.

First election of officers, when held.

SECTION 4. The indebtedness to be apportioned to the town of Eagle River, to bear the same ratio to that apportioned to each of the other towns

Indebtedness to be equally apportioned.
