CHAPTER 234.

AN ACT to appropriate to V. A. Henwood a sum of money therein named.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :

SECTION 1. There is hereby appropriated out of any money in the treasury, not otherwise appropriated, the sum of one hundred and eleven dollars, as compensation for the services of V. A. Henwood, as legislative employe, from the beginning of this session to February 20th, 1885. Appropriation.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 235.

AN ACT to authorize E. J. Homme to construct and maintain a dam across the Embarrass river, in Shawano county, for manufacturing and hydraulic purposes.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. E. J. Homme, or his assigns, are hereby authorized to construct and maintain a dam across the Embarrass river, on lands owned by said E. J. Homme, in the county of Shawano, described as the north half of the northwest quarter of section ten, township number twenty-seven, range eleven east; said dam to be constructed for hydraulic and manufacturing purposes, and for the purpose of facilitating the driving of logs and timber down said stream; said dam may be built to a sufficient height to raise a head of water not to exceed fourteen feet above low water mark; provided, that said dam shall not interfere with the rights of any person heretofore acquired. The Authorized to construct a dam across Embarrass river.

aforesaid person, his successor or assigns, shall build suitable slides in said dam for the running of logs, timber and lumber over the same, and shall keep the same in repair; provided, also, that the legislature reserves the right to alter, amend or repeal this act whenever, in its judgment, the public interest shall so require.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 236.

AN ACT to authorize John H. Knapp, Henry L. Stout, Andrew Tainter, William Wilson, Thomas B. Wilson and John H. Douglas, their assigns or legal representatives, to construct and maintain a dam across Little Bear Creek, in Barron county, Wisconsin.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :

Authorized to construct a dam across Little Bear Creek.

SECTION 1. John H. Knapp, Henry L. Stout, Andrew Tainter, William Wilson, Thomas B. Wilson and John H. Douglas, their assigns or legal representatives, are hereby authorized and empowered to construct and maintain a dam in and across Little Bear Creek, a tributary of the Red Cedar River, on lands owned by the Knapp, Stout & Co. Company, to wit: The southwest quarter of the northwest quarter of section twenty-three, town thirty-six, range twelve west, Barron county, Wisconsin; provided, that the rights and interests of the owners of lands adjacent thereto, or in lands overflowed by reason of the erection and maintenance of said dam, and all damages sustained thereby, shall be adjusted and settled as provided in chapter 318, of the laws of Wisconsin for the year 1882; and provided further, that the water of said Little Bear Creek shall not be raised by reason of the construction and maintenance of said dam to exceed sixteen feet head above the ordinary water level, at the point
