CHAPTER 332.

AN ACT relating to the University, providing for building Science Hall and other buildings, and making appropriations therefor.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Science hall to be erected, plans, etc.

SECTION 1. The regents of the university are authorized and required, at the earliest practical time, to secure suitable plans for the erection of an adequate and convenient edifice in place of the science hall recently destroyed by fire, and also a proper building for a machine and carpenter shop and the necessary engine, and for steam boilers for heating the buildings mentioned in this act; and also a separate edifice for the chemical department containing suitable lecture rooms, laboratories for assaying and for qualitative and quantitative analysis and other convenient rooms; and to proceed with the construction of such buildings upon the grounds of the university with as much diligence as may consist with proper performance of the work. All such buildings shall be built with a view to their being substantially fire-proof.

Appropriation.

SECTION 2. For the purpose, mentioned in the first section, there is hereby appropriated from the general fund so much as shall be necessary, not exceeding the several sums respectively following: For the science hall, machine and carpenter shop, engine and boiler house, one hundred and fifty thousand dollars; for the building for the chemical department, twenty thousand dollars; for heating apparatus for all of said buildings, twenty thousand dollars; provided, not more than one hundred thousand dollars thereof, shall be drawn from the treasury during the year 1885, and the residue during the year 1886.

Necessary equipment may be obtained.

SECTION 3. The said regents are also authorized and required to procure the necessary equipment, apparatus, cabinets and means of illustration and instruction to properly furnish and equip such buildings, so far as may be done with the moneys

received or to be received for insurance on the property which has been destroyed, which they are hereby authorized to expend therefor.

SECTION 4. This act shall take effect upon its passage.

CHAPTER 333.

AN ACT to amend section 4, of chapter 342, laws of 1883, relating to suppression of vagabondage.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. To amend section 4, of chapter 342, laws of 1883, by adding after the word, "commissioners," in the fifth line of said section, the words, "and police justices in incorporated villages," so that said section, when amended, shall read as follows: Section 4. For the apprehension of any person or persons, charged with being a tramp, under the provisions of this act, the judges of the several courts of record, in vacation as well as in term time, court commissioners and police justices, in incorporated villages, are hereby authorized to issue process to carry into effect the provisions of this act, and all proceedings for the arrest and examination of offenders shall be had and conducted under the provisions of chapter 195, of the revised statutes, except that no police justices in incorporated villages issuing such warrant shall have jurisdiction to try the same.

Suppression of vagabondage.

SECTION 5(2). This act shall take effect and be in force from and after its passage and publication.

NOTE BY THE SECRETARY OF STATE.—The foregoing act having been presented to the governor for his approval, and not having been returned by him to the house of the legislature in which it originated, within the time prescribed by the constitution of the state, has become a law without his approval.
