## CHAPTER 406.

AN ACT to authorize the city of Milwaukee to pay certain claims to Tilly Lynde for constructing and improving certain streets in the Second and Ninth wards of said city, and providing for the payment thereof out of the ward funds of said wards.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*

SECTION 1. The city of Milwaukee is hereby authorized to allow and pay to Tilly Lynde, or his assigns, out of any moneys in the treasury of the city of Milwaukee, belonging to the ward funds of the second and ninth wards of the city of Milwaukee, respectively, any judgment or judgments obtained by said Tilly Lynde against said city of Milwaukee, for the construction or improvement of certain streets in said wards respectively, and if any judgment or judgments shall be rendered against said city of Milwaukee, for the construction or improvement of streets by said Tilly Lynde in said wards respectively, the said judgment or judgments shall not be paid out of the moneys in the

treasury of said city belonging to any other funds.

## CHAPTER 407.

AN ACT to amend chapter 62, laws of 1883, entitled, "An act relating to the preservation of fish in the lakes, bayous and sloughs of the Mississippi River.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

Preservation of fish in the sloughs of the Mississippi.

SECTION 1. Section 1, of chapter 62, of the laws of 1883, is hereby amended by inserting after the word, "lakes," in the second line of said section the words, "except Lake Pepin" so that said section when so amended shall read as follows: Section 1. Any person who shall catch or take from the lakes (except Lake Pepin), bayous or sloughs directly leading into the Mississippi River, or from the Mississippi River, within the limits of the state of Wisconsin, any fish, except mullets, suckers, bill fish, bull heads or dog-fish, by the use of any device other than by spear, hook and line or angling, shall be punished by a fine not more than fifty dollars; and any seine, net or other device so used shall be forfeited to the state. Provided, that this act shall not be construed to prevent any person from catching minnows for bait.

SECTION 2. All acts or parts of acts, inconsistent with the provisions of this act are hereby repealed.

SECTION 3. This act shall be in force from and after its passage and publication.
