CHAPTER 415.

AN ACT to provide for the payment of a license fee by the owners of palace, drawing room and sleeping car companies.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Payment of license fee from owners of palace cars demanded.

SECTION 1. Section 4, of chapter 353, of the laws of 1883, entitled, "An act to provide for the payment of a license fee by the owners of palace, drawing room and sleeping car companies," is hereby amended by striking out the word, "two (2)" where it occurs in the second line of said section and inserting the word, "four (4)" so that said section when so amended shall read as follows: "Section 4. The annual license fee to be paid by such owner as aforesaid shall be four (4) per centum of the earnings reported as required by section 2 hereof; the amount of such license fee to be computed by the railroad commissioner and by him certified to the state treasurer.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 416.

AN ACT to amend section 27, of the revised statutes, relating to the division of towns into election districts.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Division of towns into election districts.

SECTION 1. Section 27, revised statutes, is hereby amended by adding at the end thereof, the following: The town board shall be required to make such divisions, upon the petition in writing

of fifty or more electors of any town. This act shall apply to all elections, whether general, special or town elections; provided, that all town meetings be held at the polling place to be known as the first precinct.

SECTION 2. This act shall take effect and be in force from and after its passage.

CHAPTER 417.

AN ACT to amend sections 1, and 2, of chapter 182, laws of 1879, relating to the fisheries of the lower Fox River.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :

SECTION 1. Section 1, of chapter 182, of the laws of 1879, is hereby amended by adding to the end of said section as follows: But nothing herein shall prevent fishing in the lower Fox River from the dam at the city of Depere to the mouth of said Fox River, including all streams, bayous, marshes or waters adjacent thereto, except from the first day of October to the first day of May of each year, and then only with gill nets and dip nets, with not less than four and one-fourth inch meshes or two and one-eighth inch bar measure from knot to knot.

Relating to fisheries in the lower Fox river.

SECTION 2. Section 2, of the same chapter is hereby amended by adding to the end of said section as follows: Excepting in the lower Fox River from the dam at the city of Depere to the mouth of said river, as provided in section 1, of this act.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.
