

section as heretofore amended, viz: Provided, that no county clerk shall be liable to any penalty or to the forfeiture of any sum whatever, for causing such publication to be made in a weekly newspaper published in such county, for two years or more next prior to the date of such county clerk's notice, when by reason of accident or other cause more than one week has intervened between the dates of its actual issue to subscribers, if such delay at any one time shall not have exceeded three days. But every such newspaper, for all the purposes of this section, shall be deemed to have been regularly published once in each week, as hereinbefore provided.

SECTION 2. This act shall take effect and be in full force from and after its passage and publication.

CHAPTER 187.

AN ACT to amend section 604, chapter 32, revised statutes, relating to sheriff's fees for removing persons to the insane asylums.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

604, R. S.

SECTION 1. Amend section 604, chapter 32, revised statutes, by striking out the word, "five," where it occurs in said section, and insert in place thereof the word, "ten," so that said section when amended shall read as follows: Section 604. The sheriff shall be allowed the following fees: For arresting and bringing a person charged with insanity before the county judge and subpoenaing witnesses, the same fees as are allowed in other cases; for taking an insane person to the hospital or removing one therefrom, ten cents per mile going and returning, and six cents per mile going and returning for each assistant, and one dollar

and fifty cents a day for the support of each patient on his journey to and from the hospital, and his actual expenses for the transportation of such insane person only; witnesses subpoenaed before the county judge, the same fees as allowed by law in other cases, said fees and charges to be paid out of the county treasury.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 188.

AN ACT to appropriate the sum of two thousand dollars, or so much thereof as may be required, to aid in securing an exhibit of the condition and work of the public schools of Wisconsin at the national centenary school exposition in Chicago, in July, 1887.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. For the purpose of aiding in securing an exhibit of the condition and work of the public schools of Wisconsin at the national centenary school exposition, to be held in the city of Chicago, Illinois, in July, 1887, in connection with the annual meeting of the national educational association, and the celebration of the one hundredth anniversary of the passage of the ordinance of 1787, there is hereby appropriated out of any money in the treasury belonging to the general fund, not otherwise appropriated, the sum of two thousand dollars, or so much thereof as may be necessary for that purpose.
