Duties of the treasurer defined.

SECTION 3. Section 6, of chapter 4, of chapter 127, of the laws of 1887, is hereby amended to read as follows: Section 6. The city treasurer shall perform all the duties required of him by law; collect all city, county and state taxes, and pay over the money in his hands according to law. He shall keep in the proper books an account of all moneys received and of all moneys paid out, and the same shall at all times be open to the inspection of the voters of said city. He shall make reports monthly, and render an itemized account to the common council of all sums received, when any by whom the same was paid, and also of all moneys by him paid out, which shall be published in the city paper; such reports to state the amount of money on hand. The treasurer of the city of Ashland in no case shall receive more than five per cent. on the sums by him collected, and shall be ineligible for re-election for one year next succeeding the termination of his office.

SECTION 4. This act shall take effect and be in force from and after its passage and publication. Approved April 11, 1887.

## CHAPTER 406.

AN ACT to amend section 61, chapter 134, laws of 1883, entitled, "an act to incorporate the city of Tomah."

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

City limits, and other amendments.

SECTION 1. Section 61, of chapter 134, of the laws of Wisconsin, entitled, "an act to incorporate the city of Tomah," is hereby amended, by

adding thereto the following: The territory embraced within said city limits, and the southwest quarter of the northeast quarter of section thirty-three, in said township eighteen north, of range one west, and the inhabitants thereof, are hereby attached to, and shall hereafter constitute a part of school district number one, of the city of Tomah, for all school purposes, and the inhabitants of such territory so attached shall have all the rights and privileges of residents of said school district in the schools and school meetings of said school district number one, of the city of Tomah, and the general laws relating to joint school districts between towns, and regulating the levy and collection of school taxes upon the territory so attached and the inhabitants thereof, and the payment thereof to the treasurer of said school district number one, of the city of Tomah, shall apply to and govern the town of La Grange in its relations to said school district number one of the city of Tomah, so that said section when so amended shall read as follows: Section 61. The common schools of the city of Tomah shall be under the control and supervision of the school district board of each district in the same manner as if this act had not passed, and the same relations shall be sustained between said city and such schools, as near as may be, as between towns and school districts therein, and the same reciprocal powers and duties, and until otherwise provided by the common council of said city. The territory embraced within said city limits, and the inhabitants thereof, shall constitute one school district, to be known as school district number one of the city of Tomah. The officers of school district number one of the town of Tomah, shall be the officers of said school district number one of the city of Tomah, during their unexpired term, and until their successors are elected and qualified in accordance with the laws of the state of Wisconsin regulating school districts; and all real estate and personal property belonging to school district number one of the town of Tomah, is hereby vested in school district number one, of the city of Tomah. And the territory embraced within said city limits, and the southwest quarter of the northeast quarter of section thirty-three, in said township eighteen north,

## CHAPTER 409.

AN ACT to revise, consolidate and amend the act incorporating the city of Berlin, and the several acts amendatory thereof.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

### CHAPTER I.

#### INCORPORATION.

SECTION 1. All that district of country in the counties of Green Lake and Waushara, contained within the limits and boundaries hereinafter described shall be a city by the name of "Berlin," and the people who now inhabit, and those who shall hereafter inhabit the same, shall be a mu-
