

and after such graduation shall furnish evidence to the state superintendent of good moral character and of successful teaching for one school year in a public school of this state, may have his diploma countersigned by said superintendent, which shall then have the force and effect of * * * *an unlimited state certificate*, subject to the exercise of the power vested in the state superintendent to revoke the right given by his signature to such diploma.

SECTION 2. All acts or parts of acts inconsistent with this act are hereby repealed.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 67.

AN ACT to amend section 4404 of the statutes, relating to arson.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section 4404 of the statutes is amended to read: Section 4404. The preceding sections of this chapter shall severally extend to a married woman who may commit either of the offenses therein described, though the property burnt or set fire to may belong partly or wholly to her husband; and said sections shall also severally apply to a married man, though the property burnt or set fire to may belong partly or wholly to his wife, and though said property may be occupied by such married man or married woman, or by such married man and wife as a residence.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 68.

AN ACT to amend section 935 of the statutes, relating to the annual reports of library directors.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section 935 of the statutes is amended to read: Section 935. *On or before the first day of October of each year*

the said board of directors shall make an annual report, *for the year ending on the preceding thirtieth day of June. Such report shall be submitted * * * to the council or proper board * * * and shall state* the condition of their trust, the various sums of money received from the library fund and all other sources, and how much money has been expended, the number of books and periodicals on hand, the number added during the year, the number lost or missing, the number of books loaned out, and the general character of such books, with such other statistics, information and suggestions as they may deem of general interest, and they shall send one copy of this report to the Wisconsin free library commission. The said board shall also include in the said annual report the names of the directors whose terms expire at the time the report is made.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 69.

AN ACT to amend section 976s of the statutes, relating to eligibility for municipal offices of persons interested in contract for furnishing public utilities.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section 976s of the statutes is amended to read: Section 976s. No person shall be eligible to any * * * city office who directly or indirectly has any pecuniary interest in any contract for furnishing heat, light, water, power or other public service to or for such * * * city * * * or who is a stockholder in any corporation which has any such contract.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.
