**CHAPTER 255.**

AN ACT to amend section 459 of the statutes, relating to legal school holidays and attendance upon institute or teachers' association.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Section 459 of the statutes is amended to read: Section 459. Twenty days of teaching shall constitute a school month unless it be otherwise specified in the contract, and all legal holidays, except the day of any primary election or any general election occurring on school days shall be counted although no school be taught; but school taught on legal holidays shall not be counted for two school days, and no Saturday shall be counted. The board may give to any teacher employed, without deduction from his wages, the whole or any part of any time spent by him in attending the sessions of any institute held in the county embracing any part of the district, *in attending a school board convention*, or in attending the meeting of any teachers' association, upon such teacher furnishing to the clerk, to be filed by him, a certificate of regular attendance on such institute, *school board convention*, or teachers' association, signed by the person conducting the institute *or convention* or by the secretary of the association.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

**CHAPTER 256.**

AN ACT to amend section 850 of the statutes, relating to compensation of town officers.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Section 850 of the statutes is amended to read: Section 850. *The compensation of supervisors shall be fixed by the annual town meeting. The clerks of the polls and town clerks shall be entitled to a compensation of two dollars per day, and at the same rate for parts of a day for each day and for each part of a day actually and necessarily devoted by them to the service of the town and in the discharge of any of the duties of their respective offices required of them by law, \* \* \* unless the town shall have fixed a different compensation at the*

annual town meeting. *If the town meeting shall fail to fix the compensation of supervisors, the same shall be three dollars per day and at a similar rate for parts of a day; and no town officer shall be entitled to pay for acting in more than one official capacity or office at the same time.*

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

### CHAPTER 257.

AN ACT to create section 169s of the statutes, providing for coöperation between state officers and departments.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. There is added to the statutes a new section to read: Section 169s. 1. Whenever any two or more commissions, commissioners or officers of the state may so determine by order, such commissions, commissioners or officers may coöperate in performing any specific work assigned to any one or more of such commissions, commissioners or officers and make such assignments of employees to such work as shall be found for the best interests of the public service.

2. Every such order shall be filed with the secretary of state and a report of all work done through such coöperation shall be filed at the end of each calendar year with the secretary of state.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

### CHAPTER 258.

AN ACT to amend subdivision (a) of section 4560a—16 of the statutes, relating to shipments of deer.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Subdivision (a) of section 4560a—16 of the statutes is amended to read: (Section 4560a—16) (a) Any carcass or part of carcass of any deer between the third day of December and the succeeding twelfth day of November, provided, that the shipments of green hides or green heads of deer are not to be had in possession after January third or between January third
