All such appointments shall be made by writing filed in the office of the secretary of state.

(Section 170.) 5. (c) The inspector of free high schools, twenty-five hundred dollars; the chief clerk, twenty-two hundred fifty dollars; the library clerk, eighteen hundred dollars; assistant library clerk, initial salary, nine hundred dollars, with an increase, at the discretion of the state superintendent and on the basis of increased efficiency, of not to exceed one hundred dollars per annum in any one year, the maximum salary thus reached not to exceed twelve hundred dollars per annum; three clerks and stenographer, nine hundred dollars each; an index, filing, diploma and certificate clerk, twelve hundred dollars; the mailing clerk, one thousand dollars. The inspector of free high schools shall be reimbursed his actual and necessary expenses incurred in the performance of his duty; and his salary and expenses shall be paid upon the certificate of the state superintendent, from the appropriation made for free high schools. The assistant library clerk shall be reimbursed the actual and necessary traveling expenses incurred by such clerk in the performance of his or her duties, upon the certification of the state superintendent, not, however, to exceed one hundred dollars in any one year.

CHAPTER 476.

AN ACT to create sections 4568m and 4568n of the statutes, relating to frauds or attempted frauds commonly called confidence games and defining certain procedure therefor.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. There are added to the statutes two new sections to read: Section 4568m. Every person who shall obtain, or attempt to obtain, from any other person or persons, any money or property, by means or by use of any false or bogus checks, or by any other means, instrument or device, commonly called the confidence game, shall be punished, if the money or property so obtained, or attempted to be obtained, shall exceed the value of five hundred dollars, by imprisonment in the state prison not less than one year nor more than ten years, and if the money or property so obtained, or attempted to be obtained, shall have a value of less than five hundred dollars, by imprisonment in the

county jail not more than one year or by fine not exceeding five hundred dollars.

Section 4568n. In every complaint, indictment or information under section 4568m of the statutes, it shall be deemed and held a sufficient description of the offense, to charge that the accused did, on etc., unlawfully and feloniously obtain, or attempt to obtain, (as the case may be), from A B (here insert the name of the person defrauded or attempted to be defrauded), his money (or property, in case it be not money), by means and by use of the confidence game.

Section 2. This act shall take effect upon passage and publication.

CHAPTER 477.

AN ACT to provide for the representation of the state of Wisconsin at the Panama-Pacific international exposition at San Francisco, California, celebrating the opening and commercial use of the Panama Canal, and making an appropriation therefor.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. There is created a commission to be composed of three members and to be known as the Panama-Pacific exposition commission, to represent the state of Wisconsin at the Panama-Pacific international exposition, to be held in San Francisco, California, in nineteen hundred and fifteen, and there celebrate the completion and commercial use of the Panama Canal. The members of said commission shall be appointed by the governor. No member of the 1913 legislature shall be eligible to appointment on said commission.

Section 2. Said commission shall encourage and promote a full and complete exhibit of the commercial, industrial, agricultural, live stock, and dairy interests of the state and its citizens at such exposition and celebration, and shall provide, furnish and maintain during the exposition a building or buildings for a state exhibit and for the official headquarters of the state, and for the comfort and convenience of its citizens and exhibitors. Said commission shall within thirty days after its appointment and upon notification by the secretary of state convenience in the city of Madison, at the state capitol, and elect a chairman and vice-chairman, and perfect its organization for the transaction of the duties devolving upon it by reason of this act.
