

(6) (af) On July 1, 1919, two thousand two hundred dollars, and on July 1, 1920, two thousand one hundred dollars, for property repairs and maintenance.

(7) (af) On July 1, 1919, three thousand dollars, and on July 1, 1920, three thousand two hundred dollars, for property repairs and maintenance.

(8) (af) On July 1, 1919, three thousand one hundred dollars, and on July 1, 1920, three thousand three hundred fifty dollars, for property repairs and maintenance.

(9) (af) On July 1, 1919, three thousand five hundred dollars, and on July 1, 1920, three thousand five hundred dollars, for property repairs and maintenance.

(10) (af) On July 1, 1919, one thousand four hundred dollars, and on July 1, 1920, one thousand four hundred fifty dollars, for property repairs and maintenance.

(f) Annually, for three years, beginning July 1, 1919, nine thousand dollars, for the purchase of land, provided that any amount or amounts received from the sale of buildings on the land purchased with funds derived from this appropriation, shall be added to this appropriation and available for the same purpose; provided further that no part of this appropriation shall be used as a down payment, or part payment on the purchase of land, but only for acquiring the full legal title in fee, without lien or incumbrance.

(11) (af) On July 1, 1919, three thousand five hundred dollars, and on July 1, 1920, three thousand five hundred dollars, for property repairs and maintenance.

SECTION 6. This act shall take effect July 1, 1919.

CHAPTER 198.

AN ACT to renumber and amend section 1636—215 of the statutes, relating to the registration of architects.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. All of section 1636—215 of the statutes except subsection 6 thereof is renumbered to be section 2394—97; and subsections 1 and 2 thereof are amended to read:

REGISTRATION OF ARCHITECTS. *Section 2394—97.*

(1) * * * No person doing business in this state shall use the term "architect" as a part of his business name or title or in any way represent himself to be an architect, without a certificate of registration, as provided in this section.

(2) * * * A board * * * *denominated* the "Board of Examiners of Architects" is created, * * * composed of the state architect, the dean of the engineering college of the state university, and three architects in good standing *appointed by the industrial commission*. Every appointed member is required to * * * have been in active practice in this state for not less than ten years previous to * * * his appointment, and the * * * first * * * three appointments shall be made for terms ending as follows: One of them on July 1, 1918, one of them on July 1, 1919, and one of them on July 1, 1920. * * * In June of each year a successor to the member whose term will expire the next following first day of July shall be appointed * * * for a term of three years. Such examiners shall be entitled to no compensation for their services under this section, * * * but their traveling and other necessary expenses shall be paid by the state. Said board shall prescribe reasonable rules and regulations for the examination and registration of candidates for certificates under the provisions of this section.

SECTION 2. Subsection 6 of section 1636—215 of the statutes is renumbered to be section 4432—9 and is amended to read:

UNREGISTERED ARCHITECTS. Section 4432—9. * * * Any person violating any provision of * * * section 2394—97 shall be deemed guilty of a misdemeanor and upon conviction thereof shall be punished for the first offense by a fine of not less than ten dollars nor more than one hundred dollars, and for a second or subsequent offense by a fine of not less than one hundred nor more than five hundred dollars, or by imprisonment for not more than one year, or by both such fine and imprisonment.

SECTION 3. Said section 2394—97 is amended by adding thereto a new subsection to read: (Section 2394—92) (6) *Any violation of this section shall be punished as provided by section 4432—9.*

SECTION 4. This act shall take effect upon passage and publication.
