CHAPTER 237.

AN ACT to create section 1022—63 of the statutes, relating to vital statistics.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is added to the statutes a new section to read: Section 1022—63. The local registrar of each township, incorporated village and city shall, on the first day of each and every month, make an exact copy of all births, marriages and deaths recorded in such city, incorporated village or township during the previous month, whenever the parents of the child born, or the bride or the groom, or the deceased person, were resident in any other city or incorporated village in this state or in any other state at the time of said birth, marriage or death; and shall transmit such copies to the registrar of the incorporated village, city or state in which such parents of the child born, the bride or groom, or the deceased, were resident at the time of said birth, marriage or death. The registrars so receiving such copies shall record the same in the books kept for recording births, marriages and deaths. Such copies shall be made upon blanks to be furnished for that purpose by the state board of health.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 238.

AN ACT to repeal subsections (1) and (2) of section 20.66; to create a new subsection of said section to be numbered (1) and to renumber subsections (3) and (4) of said section to be subsections (2) and (3) respectively, relating to circuit judges and making an appropriation.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsections (1) and (2) of section 20.66 of the statutes are repealed.

SECTION 2. A new subsection is added to section 20.66 of the statutes to read: (20.66) (1) SALARIES OF JUDGES. To each judge of a circuit court, during terms of office commencing before the first day of July, 1919, fifty-five hundred dollars, and, during terms of office commencing after the first day

of July, 1919, sixty-five hundred dollars. Each circuit judge shall also be reimbursed for necessary expenses incurred in the discharge of judicial duty outside his home county, and in attending meetings of the board of circuit judges.

SECTION 3. Subsections (3) and (4) of section 20.66 are re-numbered to be subsections (2) and (3) respectively.

SECTION 4. This act shall take effect upon passage and publication.

CHAPTER 239.

AN ACT to amend subsection 3 of section 4096 of the statutes, relating to examinations of adverse parties otherwise than as a witness on a trial.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection 3 of section 4096 of the statutes is amended to read: (Section 4096) 3. The attendance of the party to be examined, and the production of all papers, books, files, records, things, and matters in the possession of such party, his or its assignors, officers, agents, or employes, relevant to the controversy, may be compelled upon subpoena and the payment or tender of his fees as a witness. If the party to be examined is a nonresident of this state, the court may upon motion fix the time and place of such examination, *either within or without the state*. He shall attend at such time and place and submit to the examination, and, if required, attend for the purpose of reading and signing such deposition, without service of subpoena.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 240.

AN ACT to amend subsection 7 of section 669, of the statutes, relating to the powers of county boards in reference to the equipping of county offices.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection 7 of section 669, of the statutes is amended to read: (Section 669) (7) To prescribe the form
