CHAPTER 644.

AN ACT to appropriate a sum of money named therein to Ellen M. Bowers for injuries received at the state fairgrounds in September, 1910.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is appropriated from the general fund to Ellen M. Bowers, the sum of three thousand dollars, for injuries received by her while attending the state fair, held at the state fair grounds, in September, 1910; provided that this appropriation shall be in full of all claims of said Ellen M. Bowers against the state in connection with said accident.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 645.

AN ACT to repeal Chapter 376, laws of 1919, entitled "An Act to appropriate One Thousand dollars for the special committee created by joint resolution No. 29, S., to investigate the methods of doing business in this state by the International Harvester Company.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Chapter 376, laws of 1919, is hereby repealed.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 646.

AN ACT to amend subsection (5) of section 40.47 of the statutes, relating to establishment of union free high schools; and to validate action heretofore taken in the creation of union free high schools.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection (5) of section 40.47 is amended to read: (40.47) (5) In all cases the vote shall be by ballot, and the ballots shall be written or printed "For Union Free High

School" and "Against Union Free High School." The proposal shall not be deemed adopted unless a majority of the electors * * * voting in the territory outside of the village and a majority of the electors * * * voting in the village shall vote for the union free high school.

SECTION 2. All steps or proceedings heretofore had or taken in forming or creating any union free high school district are hereby validated. Provided this act shall not affect any district or districts where an action or actions are pending at the date of the passage and publication of this act, questioning the legality of the establishment of union free high schools.

SECTION 3. This act shall take effect upon passage and publication.

CHAPTER 647.

AN ACT to repeal subsection (2) of section 20.59 and to amend subsection (1) of section 20.59, relating to the appropriation for the dairy and food commissioner.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection (2) of section 20.59 of the statutes is repealed.

SECTION 2. Subsection (1) of section 20.59 of the statutes is amended to read: (20.59) (1) Annually, beginning July 1, * * * 1919, * * * seventy-five thousand * * * dollars, for the execution of his functions. Of this there is allotted to said commissioner and superintendent an annual salary of three thousand dollars.

SECTION 3. This act shall take effect upon July 1, 1919.
