CHAPTER 337.

AN ACT to amend subsection (4) of section 31.18 of the statutes, relating to the power of the railroad commission to regulate clearing of lands used for reservoirs.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection (4) of section 31.18 of the statutes is amended to read: (31.18) (4) The railroad commission may in the interest of public rights in navigable waters, or to promote safety and protect life, health and property, require the grantee of any permit, under this chapter, or of any permit or authorization heretofore provided for by legislative enactment, prior to flowing any lands by the construction of a dam thereunder, to remove from such lands all or any portion of the standing and fallen timber and all or any portion of the brush.

SECTION 2. This act shall take effect upon passage and publication.

A new subsection is added to section 29.62 and a new subsection is added to section 20.20 of the statutes to read: (29.62) (5) The state conservation commission shall also cause rough fish to be taken at any time of the year from any lakes located in counties which are entirely north of forty-four degrees thirty minutes north latitude.

(20.20) (11b) The state conservation commission shall expend from the appropriation for operation of the state conservation commission, authorized by subsection (1) of section 20.20 of the statutes, on July 1, 1925, fifteen thousand dollars to carry out the provisions of subsection (5) of section 29.62.
