### CHAPTER 413.

AN ACT to submit to the people an amendment to the constitution.

WHEREAS, At the biennial session of the legislature of this state in the year 1923, an amendment to the constitution was proposed and agreed to by a majority of the members elected to each of the two houses, which proposed amendment was in the following language:

*“Resolved by the Assembly, the Senate concurring, That section 5 of article V of the constitution be amended to read: (Article V) Section 5. The governor shall receive, during his continuance in office, an annual compensation of not less than five thousand dollars, to be fixed by law, which shall be in full for all traveling or other expenses incident to his duties. The compensation prescribed for governor immediately prior to the adoption of this amendment shall continue in force until changed by the legislature in a manner consistent with the other provisions of this constitution.”* And

WHEREAS, The foregoing proposed amendment to the constitution of this state has been approved and agreed to by the legislature thereof at the biennial session of 1925 by a majority of all members elected to each house thereof; therefore

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. The foregoing proposed amendment to the constitution of this state shall be submitted to the people at an election to be held in the several election districts in this state on the Tuesday next succeeding the first Monday in November, 1926, in

the manner provided by law for the submission of amendments to the constitution at a general election, and if the people shall approve and ratify said amendment by a majority of the electors voting thereon such amendment so ratified shall become a part of the constitution of this state.

SECTION 2. This act shall take effect upon passage and publication.

#### CHAPTER 414.

AN ACT to appropriate a sum of money to the Herman farmers mutual insurance company, being the amount of a fire insurance tax and filing fees paid into the state treasury in 1923 under protest.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. There is appointed to the Herman farmers mutual insurance company from the general fund one thousand two hundred fifty-three dollars and twenty-six cents, being the amount of a tax paid into the state treasury in 1923 under protest and which the attorney-general in an official opinion declared was unlawfully collected.

SECTION 2. This act shall take effect upon passage and publication.

AN ACT to amend section 1 of chapter 360 of the laws of 1909 as amended by chapter 560 of the laws of 1921, granting to the city of Milwaukee certain submerged lands along and adjacent to the shore of Lake Michigan and providing for the granting and ceding of such lands to Milwaukee county from the present limits of the city of Milwaukee south to section fourteen, town
