(3) * * No person, however, shall be entitled to have his name placed on such ballot who has not filed a nomination paper as provided in sections 5.05 and 5.07 of the statutes, unless he shall * * file within five days after receiving official notice of his nomination, a declaration that he will qualify as such officer if elected.

Section 2. A new subsection is added to section 20.65 of the statutes to be numbered and to read: (20.65) (2) There is appropriated from the general fund to the board of bar examiners, one thousand dollars, for the conduct of such investigations as such board may deem advisable.

CHAPTER 383.

SECTION 1. A new subsection is added to sections 45.215 and 20.03 of the statutes to read: (45.215) (3) It shall be the duty of the adjutant general to make a careful inquiry and examination for the purpose of collecting and checking the records required by this section.

(20.03) (9) To the adjutant general on July 1, 1929, five thousand dollars and on July 1, 1930, five thousand dollars to carry out the provisions of section 45.215.

CHAPTER 384.

AN ACT to create section 196.635 of the statutes, relating to the sale of appliances and other merchandise by certain public utilities.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. A new section is added to the statutes to read: 196.635 Every public utility as defined in subsection (1) of section 196.01 engaged in the production, transmission, delivery, or furnishing of heat, light or power either directly or indirectly to or for the use of the public shall keep separate accounts to show all profits or losses resulting from the sale of appliances or other merchandise. No such profit or loss shall be taken into consideration by the railroad commission in arriving at any rate to be charged for service by any such public utility.

SECTION 2. This act shall take effect upon passage and publication.
