CHAPTER 11.

AN ACT to appropriate a sum of money named therein to the interim committee on education for the preparation, printing and distribution of its report.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. There is appropriated from the general fund to the interim committee to study the educational system of the state, created by Joint Resolution No. 108 S. of the session of 1929, seven hundred fifty dollars for the preparation, printing and distribution of its report.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 12.

AN ACT to amend subsection (1) of section 76.34 of the statutes, relating to the annual license fees payable by domestic life insurance companies.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Subsection (1) of section 76.34 of the statutes is amended to read: (76.34) (1) If such company, corporation or association is organized under the laws of this state, it shall pay as a license fee for the year 1931 and annually thereafter, three and one-half per centum upon its gross income from all sources for the year ending December thirty-first, next prior to said first day of March, excepting therefrom interest required to provide and maintain reserves according to the laws of this state, income

from rents of real estate upon which said company, corporation or association has paid the taxes assessed thereon, and excepting also premiums collected on policies of insurance and contracts for annuities. * * *

SECTION 2. If a license for the year beginning March 1, 1931, shall have been issued to any domestic life insurance company prior to the taking effect of this act, and such company shall have paid a lesser license fee than that fixed in subsection (1) of section 76.34, as amended in section 1 of this act, such company shall pay the difference between such fee and the amount paid, within thirty days after the taking effect of this act.

SECTION 3. This act shall take effect upon passage and publication.

CHAPTER 13.

AN ACT to appropriate a sum of money to pay for services, labor, material and general expenses incurred by the committee in charge of the inaugural services on January 5, 1931.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. There is appropriated from the general fund five hundred seventy-three dollars and twenty-five cents to pay for services, labor, material and general expenses incurred by the committee in charge of the inaugural ceremonies on January 5, 1931, this amount to be distributed as follows: Straus Printing Company for printing programs, badges and tickets, two hundred dollars; Westby Municipal Band for music, one hundred twenty-five dollars; Rentschler Floral Company for decorations, one hundred dollars; the Mozart Club for music, fifty dollars; Roman Stangler for transportation of band instruments, five dollars; the Milwaukee Electric Railway and Light Company, transportation, forty-eight dollars; Forbes Meagher Music Company, rental and drayage of piano, ten dollars; Hotel Loraine, meals for band, thirty-five dollars and twenty-five cents.

SECTION 2. This act shall take effect upon passage and publication.
