

connection between portions of the state trunk highway system and carrying the standard markings of three or more state or federal trunk highways, may be constructed or reconstructed when deemed necessary by the city council of such city, with the approval of the state highway commission. The cost thereof shall be apportioned one-third each to the state, county and such city. The state's share of the cost of any such bridge shall be paid from the appropriation made in subsection (5) of section 20.49.

SECTION 2. This act shall apply to any bridge described in section 1 which has heretofore been authorized by the city council without the approval of the state highway commission and which is under construction or for which contracts have been let at the time this act takes effect.

SECTION 3. This act shall take effect upon passage and publication.

CHAPTER 318.

AN ACT to repeal the introductory paragraph of subsection (6) of section 29.33; and to amend the introductory paragraph and paragraphs (a), (c), and (d) of subsection (7) of section 29.33 of the statutes, relating to net fishing in Green Bay.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. The introductory paragraph of subsection (6) of section 29.33 of the statutes is repealed.

SECTION 2. The introductory paragraph and paragraphs (a), (c), and (d) of subsection (7) of section 29.33 of the statutes are amended to read: (29.33) (7) (Introductory paragraph) For the purpose of this subsection the waters of Green Bay shall be * * * *divided into two parts and all that area south of a line drawn between Limekiln bluff in Door county and the mouth of the Menominee river in Marinette county and including the Fox river as far as the dam at De Pere shall be referred to as the southern part of Green Bay and all the waters * * * in Green Bay north of the above described line shall be * * * referred to as the northern part of Green Bay.*

(a) In the southern part of Green Bay nets with a mesh not less than four inches may be used for the taking of lake trout and whitefish. Gill nets with a mesh not less than two and three-eighths inches may be used for taking herring, chub, bluefin or perch. Seines with a mesh of not less than three inches, and pound nets with a mesh of not more than two inches in the pound may be used. No nets of any kind shall be set for the purpose of catching any variety of fish during the close season for such fish. During the period from December 1 until the ice goes out gill nets with a mesh of two and one-eighth inches may be used under the ice for the purpose of catching herring, and all such nets so used shall be hung to the ice. The provisions of legal mesh herein stipulated shall be in full force and effect on and after January 1, 1925. All fish caught in nets whose use is permitted by this paragraph shall be deemed lawfully caught and possessed, except that no fish of any of the following varieties caught in seines, fyke or pound nets shall be retained, sold or transported of a length less than that specified for each variety, and such measurement of length shall be taken in a straight line from the tip of the nose to the utmost end of the tail fin, except that the measurement of dressed fish shall be the length of the carcass, namely:

Suckers with head and tail off	9 inches
Perch	7 inches
Perch with head and tail off	4 inches
Pike	13 inches
Pike with head and tail off	10 inches

Catfish	20 inches
Catfish with head off	17 inches
Any other variety	8 inches

(c) In Lake Michigan and the northern part of Green Bay gill nets with a mesh of not less than four inches may be used for the purpose of taking lake trout and whitefish. Gill nets with a mesh of not less than two and one-half nor more than two and three-

fourths inches may be used for the purpose of taking herring, chub and perch, until July 1, 1926; thereafter such mesh shall not be less than two and five-eighths inches. Gill nets with a mesh of not less than three and one-half nor more than four inches may be used for the taking of bluefin. Seines with a mesh of not less than three inches and pound nets with a mesh of not more than two inches in the pound may be used. No nets of any kind shall be set for the purpose of taking any variety of fish during the close season for such fish. Any nets with a mesh between two and three-fourths and four inches are contraband, and shall be seized and confiscated whenever found in the water or on any vessel, dock or reel. Any such contraband nets so found shall be deemed sufficient evidence of the use of such nets by the owners thereof. All fish caught in nets whose use is permitted by this paragraph shall be deemed lawfully caught and possessed, except that no fish of any of the following varieties caught in seines, fyke or pound nets shall be retained, sold or transported of a length less than that specified for each variety, and such measurement of length shall be taken in a straight line from the tip of the nose to the utmost end of the tail fin, except that the measurement of dressed fish shall be the length of the carcass, namely:

Any other variety	8 inches

(d) In *all of* Green Bay and Lake Michigan minnow seines fifty feet long and five feet deep may be used for taking rough fish minnows for bait. Each set hook licensee may use not more than two thousand feet of gill net with a mesh of one and three-eighths inches, except in reserve waters, for the purpose of taking

bloaters for bait. The provisions of subdivision (d) of subsection (7) of section 29.33, shall not take effect until January 1, 1918.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 319.

AN ACT to amend subsection (2) of section 29.285 of the statutes, relating to fishing in inland waters.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Subsection (2) of section 29.285 of the statutes is amended to read: (29.285) (2) No person shall have in his possession or under his control in *Adams, Barron, Chippewa, Columbia, Dunn, Florence, Forest, Green Lake, Iron, Juneau, Langlade, Lincoln, Marathon, Marquette, Oneida * * **, *Portage, Rusk, Sauk, Sawyer, Taylor, Vilas, Waushara, or Wood* counties any trammel, gill, hoop or any other kind of net or fish trap that might take, catch or kill fish except minnow nets as provided in section 29.32.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 320.

AN ACT to amend section 78.04 of the statutes, relating to the motor vehicle tax.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section 78.04 of the statutes is amended to read: 78.04 Each and every dealer in motor vehicle fuel who is now engaged, or may hereafter engage, in his own name or in the name of others, or by or through representatives or agents in this state, in the sale of motor vehicle fuel, shall, not later than the * * * *twentieth* day of each calendar month, render to the state treasurer on forms prescribed, prepared and furnished by
