CHAPTER 319.

AN ACT to amend subsection (2) of section 29.285 of the statutes, relating to fishing in inland waters.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Subsection (2) of section 29.285 of the statutes is amended to read: (29.285) (2) No person shall have in his possession or under his control in *Adams, Barron, Chippewa, Columbia, Dunn, Florence, Forest, Green Lake, Iron, Juneau, Langlade, Lincoln, Marathon, Marquette, Oneida * * **, *Portage, Rusk, Sauk, Sawyer, Taylor, Vilas, Waushara, or Wood* counties any trammel, gill, hoop or any other kind of net or fish trap that might take, catch or kill fish except minnow nets as provided in section 29.32.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 320.

AN ACT to amend section 78.04 of the statutes, relating to the motor vehicle tax.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section 78.04 of the statutes is amended to read: 78.04 Each and every dealer in motor vehicle fuel who is now engaged, or may hereafter engage, in his own name or in the name of others, or by or through representatives or agents in this state, in the sale of motor vehicle fuel, shall, not later than the * * * *twentieth* day of each calendar month, render to the state treasurer on forms prescribed, prepared and furnished by

said state treasurer, a sworn statement of the number of gallons of motor vehicle fuel sold by him or them during the preceding calendar month, and also on forms prescribed by the state treasurer a statement showing the amount of gasoline purchased, the name of the company from whom purchased, the initials, number and gallonage of each car purchased during the preceding month, and any additional information deemed necessary by the state treasurer. Such statements shall be sworn to by one of the principal officers in case of domestic corporations; by the resident general agent or agents, attorney in fact, or chief accountant or officers in case of a foreign corporation; by the managing agent or owner in case of a firm, association or individual; and shall contain a statement of the quantities of motor vehicle fuel sold within this state from his or their respective places of business, and if any of such motor vehicle fuel has been sold and delivered by such dealer to customers in the original packages, whether in tank cars, barrels or other packages, and in the same form and condition in which the same was imported, said statement shall show the amount of motor vehicle fuel so sold, and the names and addresses of the persons, firms or corporations to whom the same was sold.

SECTION 2. This act shall take effect upon passage and publication.
