

schools who is in the office when this act shall become effective, a person of suitable learning and experience in the art instruction, and practical familiarity with the most approved methods of organizing and conducting a system of schools, for superintendent of schools, and said superintendent of schools shall hold his office until the first day of July next following his election as herein provided, and for three years thereafter, except in case of removals as herein provided, and each third year thereafter the said board shall elect *by roll call vote* at the first regular meeting in January, a superintendent of schools, as provided herein, who shall serve for the term of three years from the first day of July next following his election.

SECTION 2. This act shall take effect upon passage and publication.

### CHAPTER 337.

AN ACT to amend section 3 of chapter 168 of the laws of 1887, relating to the third municipal court of Barron County.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. Section 3 of chapter 168 of the laws of 1887 is amended to read: (Chapter 168 laws of 1887) SECTION 3. \* \* \* *Any qualified elector* shall be eligible to the office of judge of said municipal court, \* \* \* and such judge shall hold no other county office, during the term for which he is elected.

SECTION 2. This act shall take effect upon passage and publication.

### CHAPTER 338.

AN ACT to amend subsection (2) of section 29.28 of the statutes, relating to fishing in Lake Koshkonong.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. Subsection (2) of section 29.28 of the statutes is amended to read: (29.28) (2) No person shall take, catch or kill fish, or fish for fish of any variety through the ice of any of the inland waters of the state from January first to the succeeding thirtieth day of April of any year except in \* \* \* *Lake Koshkonong and in Bayfield, Calumet, Fond du Lac, Outagamie, Waupaca, Winnebago and Waushara counties*, and except as otherwise provided in this chapter.

SECTION 2. This act shall take effect upon passage and publication.

### CHAPTER 339.

AN ACT to create subsection (10) of section 96.68 of the statutes, relating to state aid for encouraging the development and improvement of standard bred horses, and making an appropriation.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. A new subsection is added to section 96.68 (as created by chapter 67, laws of 1931) of the statutes to read: (96.68) (10) To each county, and any such organized agricultural society, association or board in the state, for the purpose of encouraging and fostering the breeding, development and improvement of standard bred horses in this state, fifty per cent of each purse of four hundred dollars and fifty per cent of each purse or five hundred dollars paid by it to the owners of the successful contestants in a two-year-old trot, two-year-old pace, three-year-old trot and three-year-old pace. Any such organization may stage any or all of said events but shall not receive state aid for more than one each of said events in any calendar year. No colt shall be eligible to enter or start therein unless owned by one or more duly qualified electors of this state or trained continuously within the state for not less than sixty days prior to the fifteenth day of June of the year in which the event is contested. After the year 1934 no two-year-old colt and after the year 1935 no three-year-old colt shall be eligible to enter or start therein, unless owned, raised
