SECTION 1. There is appropriated from the general fund to Mrs. William Van de Hey, to compensate her for the death of her husband which was caused by his being assaulted and beaten by guards of the Northern Colony and Training School at Chippewa Falls, where he was an inmate, the sum of five thousand dollars. Such sum shall be paid to the industrial commission to be dispensed as hereafter provided. The industrial commission shall pay to Mrs. William Van de Hey for the purpose of providing food, clothing and other necessaries for her minor children, the sum of sixty dollars per month for a period of one year, and the sum of fifty dollars per month thereafter until such sum of five thousand dollars has been exhausted. No part of such sum shall be used for attorney's fees. Provided that if Mrs. William Van de Hey shall remarry, or if in the opinion of the industrial commission the sums paid to her are not being used exclusively for the intended purposes above set forth, any balance remaining of such sum shall then be paid to the county court of Langlade county for the benefit of the said minor children. Acceptance of this appropriation shall operate as a full and complete release to the state of any claim on the part of said Mrs. William Van de Hey on account of the death of her husband.

SECTION 2. This act shall take effect upon passage and publication.

## CHAPTER 132.

AN ACT to amend section 35.305 of the statutes, relating to printing for veterans' organizations.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section 35.305 of the statutes is amended to read: 35.305 Upon receiving the necessary printer's copy, the director of purchases shall have printed and bound in suitable form, by the state printer, and delivered to the proper officer of each organization, all required copies of department orders, reports of officers, other historical matter and the annual proceedings of the following Wisconsin organizations of service men: United Spanish War Veterans and their auxiliary, the Wisconsin Department of the American Legion and its auxiliary, the Wisconsin Department of the Veterans of Foreign Wars and its auxiliary, and the Wisconsin Department of the Disabled American Veterans of the World War. Not to exceed two hundred dollars shall be expended annually for each of the \* \* \* four veterans' organizations named, together with their auxiliaries.

SECTION 2. This act shall take effect upon passage and publication.

## CHAPTER 133.

AN ACT to repeal and recreate subsection (22) of section 66.06 of the statutes, relating to the collection, treatment and disposal of municipal sewage and to sewerage service charges.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Subsection (22) of section 66.06 of the statutes is repealed.

SECTION 2. A new subsection is added to section 66.06 of the statutes to be numbered and to read: (66.06) (22) (a) Any town, village or city may construct, acquire or lease, extend or improve any plant and equipment within or without its corporate limits for the treatment and disposal of sewage, including the intercepting sewers necessary in connection therewith, and provide payment for the same or any part thereof from the general fund, from taxation, or from the proceeds of either municipal bonds, mortgage bonds, mortgage certificates, or as otherwise provided by law.

(b) It may provide that the entire capital, operating and other costs and expenses mentioned in paragraph (j) shall be paid out of the sewerage service charges or that only a part of these costs and expenses be so paid, and that the balance be paid from the general fund or by taxation or otherwise.

(c) A resolution specifying the method of payment shall be adopted by a majority of the members of the governing board at a regular meeting, after publication of said resolution at least one week previous in the official paper. The resolution need not be submitted to a referendum of the electors.
