

(2) All statutes governing the sentence, imprisonment and disposition of cases of female persons not enumerated in section 54.02 shall apply in all cases of such persons when subject to sentence in the Wisconsin prison for women in the same manner and to the same extent as though such sentence had been made to the state prison.

### CHAPTER 210.

AN ACT to create paragraph (ba) of subsection (4) of section 85.01 of the statutes, relating to registration fees for snowmobiles.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. A new paragraph is added to subsection (4) of section 85.01 of the statutes to read: (85.01) (4) (ba) For the registration of each snowmobile weighing less than three thousand pounds, a fee of five dollars. If the snowmobile is converted to a motor vehicle, such vehicle shall again be registered upon payment of the registration fee provided for such vehicle with allowance of credit for the registration fee paid for snowmobile.

SECTION 2. This act shall take effect upon passage and publication.

### CHAPTER 211.

AN ACT to create section 11.605 of the statutes, relating to absent voting.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. A new section is added to the statutes to read: 11.605 LIST OF ABSENT VOTERS FOR PUBLIC INSPECTION. The county, city, village or town clerk, as the case may be, shall keep a list of all electors who have made application for an absent voter's ballot or who have voted under the provisions of sections 11.54

to 11.68, with the name and address and date of application of each such elector. Such list shall be open to public inspection.

SECTION 2. This act shall take effect upon passage and publication.

### CHAPTER 212.

AN ACT to repeal subsection (1) of section 20.31, subsection (5) of section 39.11, and subsection (2) of section 39.19; to amend subsection (9) of section 39.03 and subsection (1) of section 39.19 of the statutes, relating to teachers' institutes, county superintendents and school board conventions.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. Subsection (1) of section 20.31, subsection (5) of section 39.11 and subsection (2) of section 39.19 of the statutes are repealed.

SECTION 2. Subsection (9) of section 39.03 and subsection (1) of section 39.19 of the statutes are amended to read: (39.03) (9) He \* \* \* *may* annually hold one or more school board conventions for the purpose of consultation, advice and instruction pertaining to the schools of his county. Each district clerk, \* \* \* the director and treasurer may attend such convention. \* \* \*

(39.19) (1) The county superintendent of schools \* \* \* *may* each year conduct one or more institutes for the teachers of his district. \* \* \* *There shall be no extra compensation and no expense entailed for such institutes.*

SECTION 3. This act shall take effect upon passage and publication.
