CHAPTER 492.

AN ACT to create 103.805 of the statutes, authorizing the industrial commission to fix and collect certain permit fees.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

103.805 of the statutes is created to read:

103.805 PERMIT FEES; REPORTS. The commission may fix and collect a fee not exceeding 25 cents for the issuance of each permit under the provisions of this chapter. The commission may authorize the retention of such fee by the person designated to issue permits as compensation for his services incident thereto, provided that such person is not on the pay roll of the industrial commission and provided, further, that such permit officer shall report all fees collected at such times and in such manner and form as the commission may prescribe.

CHAPTER 493.

AN ACT to repeal and recreate 111.13 of the statutes, relating to an advisory committee to the Wisconsin employment relations board.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

111.13 of the statutes is repealed and recreated to read:

111.13 ADVISORY COMMITTEE. The board shall appoint an advisory committee consisting of one member of the board who shall represent the general public and who shall act as chairman, and an equal number of representatives of employes and employers. In selecting the representatives of employes, the board shall give representation to organizations representing labor unions both affiliated and nonaffiliated; and in selecting representatives of employers it shall give representation to employers in agriculture, industrial and commercial pursuits. The board may refer to such committee for its study and advice any matter

having to do with the relations of employers and employes. Such committee shall give consideration to the practical operation and application of this chapter and may make recommendations with respect to amendments of this chapter and shall report to the proper legislative committee its view on any pending bill relating to this chapter. Members of the advisory committee shall receive no salary or compensation for service on said committee, but shall be entitled to reimbursement for necessary expenses.

CHAPTER 494.

AN ACT to amend 236.04 (2) and (3) and 236.11 (1) of the statutes, relating to land subdivision plats.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 236.04 (2) and (3) of the statutes are amended to read:

236.04 (2) All plats shall be made on one or more sheets of durable white paper so pasted on muslin that they cannot be detached therefrom. *To facilitate the binding of such sheets into volumes, as provided by section 236.11, such sheets shall be of uniform width of 22 inches and length of 30 inches. When more than one sheet is used for any one plat, they shall be numbered consecutively and each sheet shall contain a notation showing the whole number of sheets in the plat, and its relation to the other sheets. Such sheets may be provided by the county through the register of deeds on such terms as the county board shall determine.*

(3) All plats shall be drawn with waterproof nonfading black ink on a scale showing not more than 100 feet to an inch, and the scale used shall be indicated on the plat *graphically*.

SECTION 2. 236.11 (1) of the statutes is amended to read:

236.11 (1) The register of deeds shall accept and bind as a permanent record into bound volumes, properly indexed, *the original of any final plat made, certified, indorsed, acknowledged,*
