CHAPTER 504.

AN ACT to create 20.05 (8) of the statutes, relating to expenses incident to investment of state funds, and making an appropriation.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

20.05 (8) of the statutes is created to read:

20.05 (8) EXPENSE OF MAKING INVESTMENTS. Such sums as may be necessary for payment of the cost of postage, insurance and other expenses incident to the purchase or sale of bonds purchased for the general fund under section 14.67.

CHAPTER 505.

AN ACT to amend 274.01, 274.09 (2) and 274.33 (2) of the statutes, relating to appeals to the supreme court.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 274.01 of the statutes is amended to read:

274.01 *Except as otherwise specially provided*, the time within which a writ of error may be issued or an appeal taken to obtain a review by the supreme court of any judgment or order in any civil action or special proceeding in a court of record is limited to 6 months from the date of the entry of such judgment or order, but if the person against whom a judgment is rendered

is, at the time of the rendition thereof, either a minor or insane, or imprisoned on a criminal sentence, the time during which such disability shall continue, not exceeding 10 years, shall not be reckoned a part of said 6 months; said 6 months shall begin to run immediately from the entry of such judgment or order.

SECTION 2. 274.09 (2) of the statutes is amended to read:

274.09 (2) Said right of appeal applies to final orders and judgments rendered upon appeals * * * *from or* reviews of the proceedings of tribunals, boards and commissions, *and to final judgment and orders whether rendered in action or in special proceedings* without regard to whether *the actions or* * * * proceeding * * * involves *new or old rights*, remedies or * * * *proceedings and whether or not the right to appeal is given by the statute which creates the right, remedy or proceeding.*

SECTION 3. 274.33 (2) of the statutes is amended to read:

274.33 (2) A final order affecting a substantial right made in special proceedings, *without regard to whether the proceedings involve new or old rights, remedies or proceedings and whether or not the right to appeal is given by the statute which created the right, remedy or proceedings*, or made upon a summary application in an action after judgment.

CHAPTER 506.

AN ACT to repeal 343.432 (2), to amend 343.341, and to create 343.341 (2) of the statutes, relating to the manufacture, distribution and use of cheating tokens, etc.; and providing a penalty.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 343.341 of the statutes is amended to read:

343.341 (1) Any person who, with intent to cheat or defraud the owner or lessee or other person entitled to the contents of any telephone or other box, receptacle, depository or other contrivance intended for the receipt or deposit of coins or knowing
