CHAPTER 587.

AN ACT to reconcile the conflicts between chapter 580, laws of 1945, relating to the Wisconsin department of veterans' affairs, and other acts of the same session relating to veterans, to correct section references in the statutes, renumber for better location, and to make clear the legislative intent.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. The amendment made to 14.71 (1) by chapter 513, laws of 1945, is not repealed by chapter 580, laws of 1945. Both amendments stand. The purpose of this enactment is to repel any implication that the later act repealed the earlier one.

SECTION 1a. 20.03 (7), as amended by acts of the 1945 session, is renumbered 20.036 (7) and the introductory paragraph is amended to read:

20.036 (7) (Introductory paragraph) *From the general fund*, for the Grand Army Home for Veterans:

SECTION 2. 20.03 (9) is amended by substituting "45.42" for "45.215".

SECTION 2a. 20.03 (9), as amended by this bill, is renumbered 20.036 (8) and amended to read:

20.036 (8) Annually, *from the general fund*, beginning July 1, 1943, \$3,750 to carry out the provisions of section 45.42.

SECTION 2b. All expenditures under section 20.03 (7) and (9) authorized by the adjutant general from and including August 28, 1945 to the effective date of this act are hereby validated.

SECTION 3. 20.036 (1), as created by chapter 580, laws of 1945, is amended by substituting "section 45.35" for "sections 45.35 and 45.36".

SECTION 4. 20.036 (2), as created by chapter 409, laws of 1945, is renumbered 20.036 (6) and amended to read:

20.036 (6) All money paid into and credited to the post-war rehabilitation trust fund from repayments of loans made under section 45.35 (8b) are appropriated from said trust fund to the * * * *Wisconsin department of veterans' affairs* to be used by it to make loans under section 45.35 (8b).

SECTION 4a. 20.036 (5), as created by chapter 580, laws of 1945, is amended to read:

20.036 (5) On July 1, 1945, the balances of the respective appropriations for the fiscal year ending June 30, 1945, under sections 20.035, 20.036, 20.15 (1), * * * 20.156, 20.03 (7) and (9).

SECTION 4b. 20.77 (10), as amended by chapter 293, laws of 1945, is amended by substituting '20.036 (7) (c)' for '20.03 (7) (c)'.

SECTION 5. 25.281 is amended by substituting "section 45.38 (1)" for "subsection (2a) of section 45.27".

SECTION 6. The title to Chapter 45 of the statutes shall read: **VETERANS' AFFAIRS, BENEFITS AND MEMORIALS.**

SECTION 7. 45.07 (4), as created by chapter 113, laws of 1945, and 45.07 (5), as created by chapter 411, laws of 1945, are renumbered 45.37 (7) and (8), respectively.

SECTION 8. 45.10 (2), as created by chapter 550, laws of 1945, is amended by substituting "45.43 and 45.44" for "45.40 and 45.41".

SECTION 9. 45.277 is amended by substituting "45.38 (1)" for "45.27 (2a)".

SECTION 10. 45.30 (2), as amended by chapter 238, laws of 1945, is amended to read:

45.30 (2) Before adjudging a veteran insane in accordance with law, the court, upon the receipt of a certificate of eligibility from the veterans' administration, may commit such veteran to a veterans' administration facility to be detained for a reasonable length of time, to be fixed by the court, for the purpose of observation. Whenever an application to determine insanity is made in the manner prescribed by section 51.01, the court shall make such inquiry as may be necessary and proper to ascertain whether the alleged insane person is eligible for treatment in a veterans' administration facility, and shall notify * * * *the Wisconsin department of veterans' affairs* of the pendency of such action and of the commitment.

SECTION 11. 45.35 (5a), as created by chapter 409, laws of 1945, is repealed.

SECTION 11a. 45.35 (8a), as amended by chapter 580, laws of 1945, is amended to read:

45.35 (8a) The board may extend to any such veteran or any of his dependents such temporary emergency aid or relief as it may deem advisable to prevent want or distress, *except that this*

subsection does not apply to any veteran whose total period of service has been as a student detailed for training under the army specialized training program, the army air forces college training program, the military or naval academies, or any similar program under the jurisdiction of the navy, marine corps, or coast guard. The benefits and aids provided under section 45.35 shall not be assignable and shall be exempt from garnishment and execution.

SECTION 12. 45.35 (8b) and (8c), as created by chapter 409, laws of 1945, are amended by substituting "section" for "chapter" wherever the latter occurs.

SECTION 12a. 45.37 (2) (Introductory paragraph), as renumbered by chapter 580, laws of 1945, is amended by substituting '20.036 (7)' for '20.03 (7)'.

SECTION 13. 45.40 and 45.41, as created by chapter 550, laws of 1945, are renumbered 45.43 and 45.44.

CHAPTER 588.

AN ACT to reconcile the conflicts between chapter 585 (268-S), laws of 1945, which revised the laws relating to relief, old-age assistance, aid to dependent children and blind aid, and other acts of the same session relating to those subjects, to correct section references in the statutes, renumber for better location, and to make clear the legislative intent.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. This act does not give effect to any mentioned bill or portion thereof which is never enacted. If any bill herein referred to or any portion of such bill fails, any section of this bill relating thereto is of no effect.

SECTION 2. 20.18 (5a), as created by chapter 562, laws of 1945, is amended to read:

20.18 (5a) For aid to counties a sum sufficient to be allotted as provided in section 49.26 * * * (11).

SECTION 3. 20.18 (10), as created by chapter 578, laws of 1945, is renumbered 20.18 (11).
